

How to Complete the Authority to Arrest Form

Designate Precinct

Write the name of the precinct the property is located in.

Line 1 - "Premises Known as"

Complete this space with the name of the property if it has one (e.g., Villa Linda Apartments, or Rick and Tony's Auto Repair Shop, Vacant lot #123, Vacant House).

Line 2 - "Located at"

Give the exact address of the property if it has one or directions to the premises (e.g., 1234 North 56th Street, Northeast corner of Main Street & Maple Avenue).

Personal Information

Please provide us with this information including a mailing address so we can identify you as the responsible person in the event of an arrest. Two areas are provided for both the owner and agent or an alternate responsible party. This information is for prosecution purposes only.

Title

We need to know what position you hold relative to the property in question (e.g., owner, manager, agent).

Authority To Arrest Trespassers

The undersigned owner, occupant or designated agent for the premises known as:

(circle ones that apply) the Vacant Lot, Vacant Residence, Business, Common Areas, Parking Lot

Phoenix, AZ., hereby authorizes the Phoenix Police Department to patrol the premises indicated above and arrest persons trespassing pursuant to Arizona Revised Statutes sections 13-1501 through 13-1504. Trespassers include those who are not on the premises to visit or conduct lawful business with the management or a resident of the premises. A person commits Criminal Trespass by knowingly: 1) entering or remaining unlawfully on any real property after a reasonable request to leave by the owner or any person having lawful control over such property, or 2) are on the premises after a reasonable notice prohibiting entry. This authority applies 24 hours a day.

The under signed agrees to cooperate fully in the prosecution of persons subsequently arrested for trespassing violations occurring on the premises.

This form is valid from the date of signature for two years. Any changes in ownership or management must be noted to the police department as soon as possible.
