SUBJECT: COMMUNITY BUDGET HEARINGS

This report transmits minutes from the first three community budget hearings. These hearing were held on Tuesday, April 1, 2014 at Helen Drake Senior Center, Phoenix College and Cesar Chavez High School.

The community budget hearings will be held through April 22. Staff will continue to transmit minutes and comments received about the budget proposal each week.

The minutes from the first three community budget hearings and electronic comments are provided below.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS COUNCIL DISTRICTS 1 & 5 HELEN DRAKE SENIOR CENTER APRIL 1, 2014

Councilwoman Thelda Williams opened the community budget hearing at 6:09 p.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget. She introduced Deputy City Manager Deanna Jonovich and Budget & Research Director Mario Paniagua.

Ms. Jonovich thanked those in attendance and presented the overview video describing the proposed budget. Following the presentation, Councilwoman Williams opened the hearing to public comments.

- Linda Anderson asked what fund paid for City Council and City management salaries. Councilwoman Williams responded the salaries were paid out of the General Fund. Ms. Anderson recommended all employees, including police and fire, take a 3% pay cut to balance the budget.
- Jennifer Langdon spoke in opposition to reducing services that impact those with disabilities specifically the closing of Pioneer Pool and the elimination of closed captioning services.
- 3. Coni Cabot proposed increasing revenue to help the budget deficit instead of eliminating services.
- 4. Frank Steinmetz expressed support for reinstating the sales tax on food.

Councilman Daniel Valenzuela joined the meeting at 6:34 p.m.

- 5. Joyce Steinmetz submitted a card recommending a new fee for all mountain rescues and expressing support for reinstating the sales tax on food.
- 6. Hope Gavin spoke in support of funding senior centers and invited City leaders to visit senior centers to see how beneficial they are to the community.
- 7. Geoffrey Gonsher thanked Councilwoman Williams for supporting arts programs and spoke of restoring arts programs.
- 8. Rivko Knox spoke in favor of a sales tax on services in order to avoid budget reductions.
- 9. Joe Williams in support of funding senior centers.
- 10. Sherry Dudek spoke in favor of hiring more police officers, reinstating the sales tax on food and proposed new revenue sources. She spoke against the reductions to neighborhood inspectors and Police Central Booking.
- 11. Sharon Parks suggested ideas to increase revenue such as increasing community center membership fees and a sales tax on services.

- 12. Barb Heller spoke in favor of reductions to the Public Information Office and increasing revenue through taxes, fines and fees.
- 13. Paul Schildgen spoke in support of maintaining services at senior centers.
- 14. Nancy Burnett submitted a card to maintain services at community centers.
- 15. Mario Horabuena expressed concern about the closure of senior centers and described how beneficial they are to the members that visit the centers on a daily basis.
- 16. Diana Cameron in support of maintaining funding for community centers. She asked the City Councilmembers what they felt was the best thing about senior centers. Councilwoman Williams and Councilman Valenzuela responded to Ms. Cameron's question.
- 17. Sylvia Mejia spoke in support of maintaining funding for senior centers, recommended a fee for using hiking trails and proposed a salary reduction for middle managers and executives.
- 18. Ben Kuglar spoke in favor of eliminating the surveillance aircraft from the Police department; increasing reward incentives to employees for cost saving ideas; and suggested the City review the volunteer process to make it easier for people to volunteer.
- 19. Gene Blue spoke in favor of summer youth programs and reinstating the sales tax on food. He suggested a private-public partnership for parks sponsorships.
- 20. Sabrina Tayor spoke against the elimination of the Police Department Central Booking and spoke in favor of increasing current revenue sources and finding new revenue sources.
- 21. Diane Harris spoke in favor of a sales tax on services and employee restorations.
- 22. Jose Paredes expressed safety concerns at the intersection of 35th and Dunlap Avenues. He spoke in favor of supporting youth programs and against reductions to street maintenance programs.
- 23. Jason Whitaker expressed concern of the safety at the intersection of 35th and Dunlap Avenues.
- 24. Edith Schnauffer submitted a card requesting the Helen Drake Senior Center not be cut.
- 25. Elizabeth Benning spoke in favor of reinstating the sales tax on food to help the budget deficit.
- 26. Regina Nixon spoke in support of maintaining funding to art education programs.
- 27. Phil Hourican submitted a card in favor of increasing public transportation services and keeping senior centers open.
- 28. Liz Hourican submitted a card in favor of increasing public transportation services and keeping senior centers open.

- 29. Peggy Odendahl spoke in favor of increasing fees at senior centers in order to keep the classes.
- 30. Ben Konik spoke in favor of increasing revenue.
- 31. Judi Rae Kell suggested increasing revenue by fining for false fire calls, charging a fee for mountain rescues and increasing the fee to other cities for Fire Dispatch Services. She spoke against the Central Booking reductions.
- 32. Mary Obrachta spoke in support of maintaining funding for senior centers, pool safety programs, code enforcement and the Fire Prevention Center. She spoke in favor of eliminating Chanel 11 and reinstating the sales tax on food. She asked how dog parks were funded. Councilwoman Williams responded the dog parks are funded by dedicated funds voted on by residents.
- 33. Barbara Gonzales spoke against funding of the Reimagine Phoenix program and stated she supported restoring Central Booking. She spoke in favor of reinstating the sales tax on food.
- 34. John loannon spoke in favor of keeping senior centers open and creating more bike lanes.
- 35. Juanita Vandever spoke in favor of keeping the Helen Drake Senior Center open.
- 36. Ron Ostrom spoke in favor of increasing revenue sources. He spoke against the closure of senior centers stating that many veterans are members and benefit from them.
- 37. Suzanne Day spoke in favor of bicycling infrastructure and asked the City Council to continue funding for additional infrastructure.
- 38. Suzanne Thraen spoke against reductions to the Police department, community center and neighborhood inspectors.
- 39. Melyna Fang spoke in favor of public safety efforts and revenue building.
- 40. Laurel Speer Petersen submitted a card to restore services at community centers as they support service to those who cannot afford other venues of entertainment.
- 41. Robin Mofford spoke in favor of increasing revenue and suggested a sales tax on online purchases. Councilwoman Williams responded a company must have a presence in the state of Arizona in order for taxes to be collectable.
- 42. Sean Mattson submitted a card with revenue generating ideas including a tax on grocery bags and a fee for using hiking trails.
- 43. Laurrie Fitzhugh recommended the budget tabloid be revised in order to make it more understandable.
- 44. Jak Keyser spoke in favor of keeping community centers open and reinstating the sales tax on food.
- 45. Mary Travis submitted a card opposed to community center closures and in favor of a sales tax on services.

Councilman Valenzuela thanked everyone for their comments and suggestions. Councilwoman Williams thanked everyone for attending and closed the Community Budget Hearing at 9:10 p.m.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS COUNCIL DISTRICT 4 PHOENIX COLLEGE APRIL 1, 2014

Councilwoman Laura Pastor opened the community budget hearing at 6:06 p.m. by welcoming those in attendance. She commented on the salary proposed for our current City Manager and that she will support his raise at the Formal Council Meeting on April 2, 2014. Adding, she also supports his new contract that eliminates pension spiking.

She introduced Deputy City Manager Rick Naimark who also thanked everyone for coming. He briefly explained the budget process and emphasized the importance the citizens' comments have on the final adopted budget. He then introduced Deputy Budget and Research Director Jeff Barton, Acting Assistant City Manager Danny Murphy and city staff in attendance. Mr. Naimark introduced the presentation which described the budget process in more detail.

Following the presentation, Councilwoman Pastor commented several Councilmembers wanted to look at innovative ways to bundle services to save money as well as thinking of new ways to generate revenue. She then opened the hearing to public comments.

- 1. Nicole Rodriguez asked to restore funding for code enforcement in Fire. She suggested other cost saving items such as eliminating the employee bus pass program; charging fees at South Mountain Park and Camelback Mountain; charging rental fees for using park ramadas; and turning off lights after hours in the parks.
- 2. Brenden Burnham suggested employees take a month furlough to solve the deficit. He also commented the public transportation system is too slow, adding there are too many bus stops on the routes.
- 3. Haley Ritter spoke in support or maintaining the summer swimming and diving programs. She also spoke in favor of improving the bicycle/pedestrian infrastructure.
- 4. Rosemary Holusha spoke in support of swimming lessons and swim and dive competitions to keep kids safe and prevent obesity. She also supported funding community and senior centers. She stated she also supports changing the retirement formula to 65 years and removing car allowances.
- 5. Lisa Parks spoke in support of bicycle infrastructure and believes bicycling is better for the economy because cyclists will stop at more businesses.
- 6. Jeremy Stapleton spoke in support of complete streets and bicycle infrastructure.
- 7. Libby Coyner thanked the City Council for the \$1.5 million for bicycle infrastructure last year and would like to continue the funding in the future.
- 8. John Walker also thanked the City Council for the bicycle infrastructure funding and supports continued funding.
- 9. John Romero also spoke in support of bicycle infrastructure funding.
- 10. Martin Vogel asked to consider revenue from activity cards, similar to what Encanto Park used to use, at Encanto as well as other city parks. He spoke in favor of 5 day work

weeks for Police staff. He also would like Police statistics to be posted online. Mr. Naimark responded staff would look into the online statistics item.

- 11. Lauren Henschen spoke in favor of selling postcard books that the City currently distributes for free as revenue to help offset Phoenix Arts and Culture Office reductions.
- 12. GG George stated she supports reinstating the sales tax on food or increasing sales tax to keep the parks, pools and libraries open. She asked what the loss of revenue to the city was this year when we dropped it 1%. Mr. Naimark and Mr. Barton responded the revenue loss was \$12.1 million for this fiscal year and \$21.3 million through March 30, 2015.
- 13. Kelly Larabee Morlan spoke in favor of keeping the swim teams and sports complex staff at Encanto Park. She added she supports reinstating the sales tax on food. She suggested setting fees for non-residents at the park.
- 14. Susan Dale spoke against cutting any services in the Parks and Recreation Department, especially Encanto Park.
- 15. Annie Eldon spoke in support of bicycle infrastructure and thanked the City Council for last year's funding. She would like to see funding for this continue.
- 16. Richard Rea spoke in favor of increasing taxes to meet the city's obligations. He stated he believes the City managers are underpaid, not overpaid. He added he supports bringing back the sales tax on food.
- 17. Gary Egan spoke in support of the Arts and Culture program.
- 18. Margie Gin spoke in support of maintaining services at the senior centers and community centers.
- 19. Ted Wiseman spoke in support of the swim and dive teams and swim lessons.
- 20. Connie Zilversmith spoke in support of the community centers and senior centers. She added she supports raising taxes to keep them open.

Afterward, Councilwoman Pastor thanked residents, city staff and her staff Monica Sandschafer and Megan Schmitz for attending this meeting. She said there are multigenerational cuts across the board. She added she believes cutting the community centers and senior centers is not acceptable.

Councilwoman Pastor closed the hearing at 7:52 pm.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS COUNCIL DISTRICTS 7 & 8 CESAR CHAVEZ HIGH SCHOOL APRIL 1, 2014

City Manager Ed Zuercher opened the Community Budget Hearing at 6:16 p.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget. He introduced Councilman Michael Nowakowski and Councilwoman Kate Gallego.

Mr. Zuercher gave a brief summary of the proposed 2014-15 budget and asked staff to present the overview video describing the process in more detail. Following the presentation, Councilwoman Gallego recognized community members and staff in attendance. She stated she has asked the City Manager to look at revenue options.

Councilman Nowakowski stated he welcomed comments on residents' needs and wants. He opened the hearing to public comments.

- 1. Michael Espinoza spoke in favor of retaining funding for Central Booking.
- 2. Elton Carey spoke in favor of keeping funding for graffiti and blight control programs and recreation centers.
- 3. David Bridge spoke in favor of maintaining service levels for the Police Department, human services, neighborhood services, trash pickup and street maintenance.
- 4. Patra Carroll spoke in favor of keeping funding for graffiti and blight control, code enforcement, community centers, and parks. She suggested finding alternative sources to fund the Super Bowl security and financing capital expenses instead of payas-you-go. She spoke in favor of balancing the budget without impacting services to South Phoenix.
- 5. Mercy Gomez spoke in favor of keeping funding for human services and parks and recreation programs for seniors and people with disabilities.
- 6. Tony Berastegui spoke in favor of increasing services, especially police and neighborhood services, to Laveen. He also asked for park maintenance for soccer fields and development of Laveen. He expressed support for retaining the city manager's compensation.
- 7. Jennifer Nelson spoke in favor of city pension reform, performance-based compensation for city employees, and economic development, recreation, swimming pools, and additional resources for the Laveen and South Phoenix areas.
- 8. Yolanda Moreno spoke in favor of keeping senior centers open, especially the South Mountain Senior Center.
- 9. Peggy Morales spoke in favor of keeping funding for swimming pools and police services. She suggested the following potential cost saving ideas: establishing fees for non-essential services; merging city departments; and hiring more retirees, veterans and interns. She advocated balancing the budget without impact to city employees.
- 10. Neal Haddad spoke in favor of adopting recommendations from citizensforphoenix.org;

increased efficiencies; and keeping funding for senior and community centers and Central Booking. He expressed support for adopting \$4 million in proposed cuts, and establishing increased, predictable revenues such as the food tax.

- 11. Erika Kennan spoke in favor of restoring the food tax, and for more development, greenbelts, transportation and bike studies, sidewalks, improved bus shelters, community centers, dog parks, senior and youth programs, and parks maintenance in Laveen. She also asked for replacement of 18 picnic tables at Cesar Chavez Park.
- 12. Claudine Reifschneider spoke in favor of restoring the food tax, and for more development, greenbelts, transportation and bike studies, sidewalks, improved bus shelters, community centers, dog parks, senior and youth programs, and parks maintenance in Laveen.
- 13. Andrew Brown spoke in favor of more youth programs in Laveen.
- 14. Hunter Franklin spoke in favor of more youth programs, a recreation center, pools with slides, basketball courts, and more resources for Laveen.
- 5. Craig Tribken spoke in favor of keeping funding and restoring funding for programs for homeless people.
- 6. David Tapley spoke in favor of funding for more bike infrastructure.
- 17. Paul Loomans spoke in favor of funding for more bike safety and infrastructure. He asked the city to follow-up on the recommendations of the bike master plan.
- 18. Amy Hale spoke in favor of keeping all swimming pools open.
- 19. Job Salinas Hernandez spoke in favor of keeping swimming pools, Harmon Park and all senior centers open, especially Marcos de Niza Senior Center.
- 20. Grace Arroyo Salinas spoke in favor of keeping open Harmon Park, Coleman Recreation Center and Marcos de Niza Senior Center. She expressed support for pool funding at Harmon Park and Coleman Center.
- 21. Muriel Smith spoke in favor of keeping current funding for parks, senior centers, neighborhood services and pools.
- 22. Mary Alvarez spoke in favor of keeping open parks and all senior centers, especially Marcos de Niza Senior Center.
- 23. Mary Hayes spoke in favor of keeping the South Mountain Senior Center open.
- 24. Debbie Zapatka spoke in favor of funding for covered bus shelters, bike lanes, community centers, extra police services, and youth programs for Laveen.

Councilmembers Kate Gallego and Sal DiCiccio opened the community budget hearing at 10:10 a.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget. Councilwoman Gallego introduced City Manager Ed Zuercher and Budget and Research Director Mario Paniagua.

Mr. Zuercher gave a brief summary of the proposed 2014-15 budget and asked staff to present the overview video describing the process in more detail.

Following the presentation, Councilman DiCiccio summarized his opposition to the proposed budget. Councilwoman Gallego expressed her disagreement with the proposed budget reductions and requested resident input for creative solutions to the budget issue.

 crime. Ms. Rogers spoke against reducing employee compensation, and she stated
 employees have taken several cuts over the past years that have not yet been
 restored.
- 4. Herlinda Cubas spoke in favor of funding for senior and community centers. She asked which centers could be affected by budget cuts. Mr. Zuercher responded to her question.
- 5. Cheryl Glenn spoke in favor of funding for senior centers and for special education. She expressed disagreement with funding for dog parks.
- 6. Barbara Gralnek spoke in favor of funding for senior centers and children's' programs.
- 7. Myron Lieberman spoke in favor of funding for senior and community centers. He spoke against funding for dog parks.
 - Mr. Zuercher responded to Mr. Lieberman's funding questions about dog parks.
- 8. Bill Sheppard spoke in favor of funding for arts grants. He stated the arts drive tourism in Phoenix and are an economic generator.
- 9. Maria Maciel spoke in favor of funding for Marcos de Niza senior center and surrounding parks.
- 10. Suzanne Amari submitted a card in favor of funding for senior centers and children's after school programs.

- 11. Francine Masterson spoke in favor of funding for senior centers.
- 12. Joseph Benesh spoke in favor of funding for arts grants. He stated arts programs for children reduce crime, including graffiti and tagging. Mr. Benesh expressed support for a plastic bag tax.
- 13. Ella Mae Clark spoke in favor of funding for senior centers.
- 14. Suzanne Smith spoke in favor of funding for senior and community centers, parks, and after school programs for children.
- 15. Lorrie Elvendahl spoke in favor of funding for senior centers.
- 16. Frank Perazelli spoke in favor of funding for senior centers.
- 17. Jasper Hawkins spoke in favor of funding for fire prevention and code enforcement services.
- 18. Lisa Parks spoke in favor of funding for senior centers, and additional bicycle infrastructure. She stated cities that have invested in bicycle infrastructure have attracted more technology companies to invest in the cities' economies.
- 19. Paul Loomans expressed his support for additional funding for bicycle infrastructure.
- 20. Libby Coyner expressed support for additional funding for bicycle infrastructure and stated bicycle infrastructure helps attract younger workers to the city.
- 21. Wayne Bowers spoke in favor of funding for senior centers. Mr. Bowers also spoke in favor of legalizing marijuana as a way to raise revenue for the city.
- 22. Anna Warble expressed support for additional bicycle infrastructure funding. She spoke in favor of funding for senior and community centers, and stated her support for a plastic bag tax. Ms. Warble spoke in favor of having teenagers clean up graffiti if they are caught defacing property.
- 23. Richard Rea stated the lack of growth in the city has contributed to the current deficit, and he expressed support for raising revenue in order to provide the public services people request. Mr. Rea stated police and fire constitute 70% of Phoenix's budget, and if people want to continue funding police and fire at this level, then revenue should increase proportionally.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS COUNCIL DISTRICT 7 SANTA MARIA MIDDLE SCHOOL APRIL 7, 2014

Mayor Greg Stanton opened the community budget hearing at 6:09 p.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget. He summarized the budget hearing process, and introduced City Manager Ed Zuercher.

Mr. Zuercher stated comment cards and the Budget Tabloids were available; the hearing was videotaped; and residents should share their priorities. He introduced Councilman Michael Nowakowski.

Councilman Nowakowski welcomed comments on residents' needs and wants. He thanked Mayor Stanton and staff for attending the meeting. Councilman Nowakowski asked staff to present the overview video describing the budget process in more detail.

Following the presentation, Councilman Nowakowski opened the hearing to public comments.

- 1. David Bridge from Central Arizona Shelter Services spoke in favor of maintaining and ensuring consistency of police coverage, funding for human services for homeless clients, and maintaining funding for homeless shelters.
- 2. Libby Coyner spoke in favor of more bike infrastructure that would promote safety and encourage bicycling. She expressed support for reinstating the sales tax on food and establishing a fee for plastic bags. She thanked the city for supporting bicycling.
- 3. Suzanne Day spoke in favor of funding bicycling infrastructure secondary to retaining funding for community centers. She expressed support for reinstating the sales tax on food and establishing new fees. She thanked the city for funding bike infrastructure last year and its positive community impact.
- 4. Paul Barnes expressed support for General Fund Proposed Departmental Efficiencies in Schedule A of the Trial Budget, reinstating the sales tax on food, and looking for predictable revenue sources. He also expressed support for maintaining current funding for the General Fund items proposed for reduction in Schedule B of the Trial Budget, and taking actions that do not negatively impact city employee compensation. He stated the budget situation sets important programs or services against others, and leads to residents advocating for competing needs.
- 5. Bill Sheppard spoke in favor of keeping current funding of arts grants and the economic benefits of arts and culture.
- 6. Robert Miley spoke in favor of keeping current funding of arts grants.
- 7. Suzanne Thraen expressed support for General Fund Proposed Departmental Efficiencies in Schedule A of the Trial Budget. She also supported keeping current funding for police, community prosecutors, central booking, community centers, pools, city employee compensation, bike infrastructure, senior centers, and restoring the sales tax on food. She suggested the Trial Budget exclude showing proposed staffing for the new dog park. She spoke in favor of items that would improve the quality of life in

south and west Phoenix and Sunnyslope.

- Mr. Zuercher noted the dog park is not funded by the General Fund.
- 8. Walt Gray spoke in favor of keeping current services which are necessities for south and west Phoenix and Sunnyslope such as workforce development programs, pools, and Phoenix Afterschool Centers. Mr. Gray spoke in favor of proper compensation for city employees and allowing labor negotiations to conclude naturally. He also expressed support for additional funding for police patrols, economic development staffing and workforce development programs. He advocated for a general sales and construction contract tax increase of one-tenth of one percent instead of reinstating the sales tax on food.
- 9. Gene Holmerud spoke in favor of more education of bicyclists' safety and rights on the road, bike infrastructure and establishing fines.
- 10. Sherry Rampy spoke in favor of funding historic preservation, which generates positive economic impact.
- 11. Bobbie McLeod spoke in favor of keeping open senior centers, especially Seniors Opportunities West (S.O.W.) Senior Center. She also expressed support for keeping central booking, civilian support for Police and Fire, and reinstating the sales tax on food.
- 12. Luis Acosta spoke in favor of ensuring there is no operating waste, keeping funding for Graffiti Busters, reallocating graffiti staff from sign enforcement, thorough graffiti removal, right-sourcing city services, and ensuring the city does not over-pay contractors. He also expressed support for not contracting with nonprofit organizations.
 - Mr. Zuercher explained that city contracts with nonprofit partners in the community when the organizations are more effective at providing services or when it is more fiscally advantageous.
- 13. Beatrice Moore spoke in favor of keeping open parks and youth programs. She suggested the city find ways to incent business owners to remove graffiti more quickly and for residents to take ownership in improving their neighborhoods. Ms. Moore commended Graffiti Busters' response times, and encouraged the city to increase partnerships with shelters for homeless people.
 - Mayor Stanton thanked Ms. Moore for all she has done in the community and explained that swift graffiti removal is key.
 - Ms. Moore suggested increasing fines to business owners that do not swiftly remove graffiti on their property.
- 14. William Buividas spoke in favor of increasing revenues, keeping all programs and services proposed for reduction, and reinstating the sales tax on food.
- 15. Victoria Jaques spoke in favor of reinstating the sales tax on food and keeping current funding for neighborhood code enforcement, graffiti removal, parks and recreation programs for youth, pools and central booking.
- 16. Roy Lee Hunter submitted a card in favor of keeping open senior centers.

17. Mayra Lozano submitted a card in favor of retaining senior centers operations, funding shelters for homeless, and increases taxes that are not sales taxes on food.

Councilman Nowakowski summarized the comments received. He stated we will need a Team Phoenix approach, and recognized Village Planning committee members for attending. He thanked everyone for attending and sharing their stories.

The hearing was closed at 7:42 p.m.

This report transmits minutes from nine community budget hearings held between Wednesday, April 8 and Tuesday, April 15, 2014.

The minutes from the nine additional community budget hearings and electronic comments are provided below.

SUMMARY MINUTES COMMUNITY BUDGET HEARING COUNCIL DISTRICT 2 TRAMANTO FIRE STATION APRIL 8, 2014

Deputy City Manager, Lisa Takata, opened the meeting at 6:01 p.m. by welcoming those in attendance and thanking them for coming to the community budget hearing and introduced Vice Mayor Jim Waring. Vice Mayor Waring also thanked those in attendance for participating.

Vice Mayor Waring gave a brief summary of the proposed 2014-15 budget and presented the overview, describing the process in more detail. Following the presentation, he opened the hearing to public comments.

- 1. Ron Christensen spoke against the City Manager's salary. Mr. Christensen was concerned about over optimistic projected revenue and also stated that Police and Fire could maybe take cuts as it would not be fair to regular employees.
- 2. Melyna Fang spoke and submitted a comment card against stopping band-aid cuts. She supports renewing the sales tax on food or possible a luxury tax to hire more police officers. She also supported corporate sponsorships for Police Department needs.
- 3. Kelly Pignato did not wish to speak but submitted a card supporting reinstating the sales tax on food as Phoenix is one of two cities that does not have this tax. Ms. Pignato stated better revenue projections are needed. She also recommended raising community center fees.

Afterward, Vice Mayor Waring thanked everyone for attending and closed the budget hearing at 6:51 p.m.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS CITYWIDE ENGLISH/SPANISH MARYVALE COMMUNITY CENTER APRIL 8, 2014

Councilman Daniel Valenzuela opened the Community Budget Hearing at 6:12 p.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget. He introduced Councilman Michael Nowakowski and Councilwoman Laura Pastor.

Councilman Nowakowski commented he welcomed comments on residents' needs and wants.

Councilwoman Pastor commented several Councilmembers wanted to look at innovative ways to bundle services and new ways to generate revenue.

City Manager Ed Zuercher gave a brief summary of the proposed 2014-15 budget and asked staff to present the overview video describing the process in more detail.

Following the presentation, Mr. Zuercher introduced Mayor Greg Stanton who welcomed residents to the hearing and stated that important changes occurred in the proposed budget every year based on the input received by residents.

Mr. Zuercher then opened the hearing to public comments.

- 1. Dwight Amery asked that no cuts be made to police and that residents need the services provided at the youth and senior centers.
- 2. Ramon Aquino spoke in favor of funding for youth programs to help low income families.
- 3. Doc Dawkins spoke to maintain community centers which provided important services to residents.
- 4. Esther Aguila Dawkins spoke to maintain community centers because they provide services for the youth in the community.
- 5. Frank Brandenburg stated the street infrastructure around the neighborhood was in desperate need of repair. He provided pictures of the street conditions at 49th Avenue and Indian School and Garfield/McKinley at 35th Avenue.
- 6. Barb Heller stated she did not support any cuts to public safety or the Graffiti Busters program. She also asked the City to look into ways to increase user fees and taxes.
- 7. Al DePascal asked the city maintain community centers and to put a freeze on merit raises of employees.

- 8. Joe Garcia spoke to maintain community centers, pools, senior centers, because these are the types of services expected when residents pay taxes.
- 9. Marge Neiman from the Desert West Center asked the city to keep the center open because of the services it provides to the community.
- 10. Ruby Hill from the Desert West Center asked the city to keep the center open because of the services it provides to the community.
- 11. Juan Juarez spoke in favor of funding for Phoenix Channel 11 because it reaches out to the community with quality programs.
- 12. Miguel Angel Lopez spoke in favor of funding for the Maryvale Community Center because of the important youth services it provides.
- 13. Liz Ricario spoke in support for public safety programs in the community and funding for the community centers which keep kids out of trouble.
- 14. Maria Myers spoke in favor of bike program funding and asked the City to keep senior centers open.
- 15. Tyler Olsen recommended that the City provide a more participatory budgeting process for citizens that other cities around the country are starting.
- 16. Luis Schmidt stated that the city and residents should work together to find creative solutions to the budget deficit, including increasing revenues and keeping important services.
- 17. Barbara Keene spoke in support of maintaining community centers and asked the city to keep funding for the Graffiti Busters program.
- 18. Linda Alonzo from the Desert West Center asked the city to keep the center open because of the services it provides to the community.
- 19. Carol Hobbs asked to maintain community centers and asked the city to look into increasing revenues rather than eliminating services.
- 20. Dorothy Gentry spoke in support of keeping senior centers open because volunteers provide important services to seniors.
- 21. Shirley Adair submitted a card questioned the need for more taxes were needed for ongoing expenditures.
- 22. Silvana Salcido spoke in favor of continued funding for the Arts Programs and the Graffiti Buster program.

- 23. Rex Gulbranson stated he appreciated the funding for the Arts and Culture programs because they provide important events for tourists and brings in additional revenue to the City.
- 24. Dion Abril spoke to support maintaining the Fire Prevention program because of the important building codes that save lives.
- 25. Victoria Jaquez spoke against any reductions to public safety, Graffiti Busters program, and community services. She also asked the city to implement new methods of generating revenue.
- 26. Andrea McCoy spoke in favor of increasing revenue to restore services to the community. She also asked the city to not cut public safety.
- 27. Norma Ramirez spoke against any reduced funding for public safety programs because those are the services needed most in the community.
- 28. Marshall Pimentel spoke in favor of generating more revenue through user fee for the Light Rail and asked the City to not reduce funding for the Graffiti Busters program.
- 29. Brenden Robert spoke to maintain community centers because kids need libraries for reading/education. He also asked the City to increase the biking program funding.
- 30. Adriana Garcia spoke against any cuts to public safety and any reduction in hours at community centers.
- 31. Rosario Guzman spoke against closing the Desert West Center because of the services provided to the elderly residents in the area. She also spoke against any cuts to public safety programs.
- 32. Liz Hourican asked the city to find creative ways to increase revenues and not eliminate services.
- 33. Phil Hourican submitted a card that asked the city to find new revenue sources instead of eliminating services.

- 34. David Solano spoke against closing community centers because of the youth programs they provide. He also spoke against the level of the City Manager's pay.
- 35. Jessica Rubio stated that dog parks should close before any of the community centers.
- 36. Rosa Pastrana asked the city to not close community centers and, in fact, more centers are needed for the Maryvale area. She also asked the city to increase revenue rather than eliminating services.
- 37. Adelaida Garcia spoke in favor of keeping funding for community centers, pools, and youth services.
- 38. Aldo Gonzalez spoke against closing any of the community centers and asked the City to find additional revenue sources to provide these important services.
- 39. Bill Scheel from the Historic Preservation Commission spoke in favor of continued funding for historic preservation programs, including a study for the Maryvale area.

Afterward, Councilman Nowakowski summarized the comments received and clarified that the City Manager received a pay increase as a result of being promoted from the Assistant City Manager position. He thanked everyone for attending and sharing their stories.

Councilwoman Pastor thanked residents and city staff for attending this meeting. She said there are multigenerational cuts across the board. She added she believes cutting the community centers and senior centers is not acceptable. She has asked staff for additional information related to community center usage and which centers are planned to be affected.

Councilman Valenzuela thanked everyone for their comments and reiterated the hard work put into the transparency of this trial budget and that everyone's comments will be incorporated into the final version of the budget.

Mayor Stanton thanked everyone for attending and closed the Community Budget Hearing at 8:15 p.m.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS COUNCIL DISTRICT 5 VILLA DE LA PAZ ELEMENTARY SCHOOL APRIL 10, 2014

Councilman Daniel Valenzuela opened the community budget hearing at 6:07 p.m. by welcoming those in attendance and thanking them for coming to comment on the proposed budget. He remarked on last year's budget compared to this year and stated it is now time to determine where the money will be coming from and the need to prioritize. Mr. Valenzuela handed the platform over to Deputy City Manager Rick Naimark.

Mr. Naimark explained the importance of budget hearings and mentioned that this is the first stage in adopting a budget. He also acknowledged city staff by raise of hands and stated they are here to help answer questions. He presented the overview video that spoke of the current budget in depth.

- 1. Walt Gray spoke in favor of supporting city programs and employee compensations and that pay agreements should only go through management and the unions. He supports a sales tax increase by raising it by an increment of 0.15% to cover the deficit.
- Jesus Rodriguez supports street repairs and also feels it assists public safety by ensuring they reach their destination safely. He is against any cuts to Streets employees.
- 3. Thomas Jones spoke in favor of Historic Preservation. He stated that adaptive reuse of public buildings will save the city money.
- 4. Suzanne Thraen spoke in favor of Fire Crisis Response teams. She also is against any cuts that will affect the protection of children, seniors, and quality of life. She also favors an increase to the sales tax by an increment of 0.15% and also suggested holding raffles.
- 5. Victoria Jaquez asked to maintain Central Booking and against the proposed cuts to NSD. She is in favor of other revenue sources.
- 6. Paul Loomans spoke in favor of cycling and increased bike infrastructure. He also stated that cyclists tend to spend money in local shops more so than car riders.
- 7. Annie Eldon spoke in favor of bike infrastructure and transit. She noted a Baltimore, MD study that showed more jobs were created from bike infrastructure than car infrastructure. She supports continued funding for cyclists.

- 8. Jimmy Arbizu spoke against cuts to employees and programs for children and seniors. He also does not support contracting out services and believes it uses more money in the long run.
- 9. Martha Dieckman commented on the City Manager's salary. She is in favor of making cuts to top executive pay but not to remaining employees. She is in favor of reinstating the sales tax on food.

Councilman Valenzuela clarified some points made and gave his closing comments. He thanked everyone for attending and concluded the hearing at 7:29.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS COUNCIL DISTRICT 8 BROADWAY HERITAGE CENTER APRIL 9, 2014

Councilwoman Kate Gallego opened the community budget hearing at 6:10 p.m. by thanking everyone for attending the meeting, and inviting them to share their thoughts regarding the Trial Budget. Councilwoman Gallego acknowledged City staff and community leaders in attendance, and introduced Ed Zuercher, City Manager.

Mr. Zuercher thanked everyone for their participation, and provided a brief overview of the budget video. Councilwoman Gallego opened the hearing to public comment after the video presentation.

- Jennifer Longdon spoke to maintain of Pioneer Pool because it was the only public barrier-free pool in the City that served disabled persons. Ms. Longdon also opposed eliminating closed-captioning for Channel 11 programs.
- Albert Blanco asked to maintain the Fire Prevention Inspectors because they
 protected the public safety officers. Mr. Blanco spoke in favor of the
 reinstituting the sales tax on food, or implementing a plastic bag tax.
- Greta Rogers asked to maintain recreational and senior centers, and reducing employees' wages. Ms. Rogers spoke in support of raising revenue through the implementation of taxes and fees, and reducing proposed expenses in next year's budget.
- 4. Carmen Arias asked to maintain recreation centers. Ms. Arias spoke in favor of constructing a community center at Lindo Park.
- 5. Gene Holmerud spoke in favor of developing programs to teach cyclists and motorists how to share the road to promote public safety.
- 6. Anthony Musa asked to maintain senior and recreational facilities and reducing the number of positions in Fire Prevention and Central Booking.
- 7. Shanna Dumas asked if operational efficiencies could be identified in programs and facilities that benefit the youth. Ms. Dumas suggested the City charge a fee when staff removes graffiti from private property.
- Michael Johnson asked to maintain recreational centers and reducing civilian
 positions in Central Booking because they placed more responsibility on Police
 Officers. Mr. Johnson spoke in favor or reinstating the sales tax on food,

- developing a summer jobs program, and utilizing resources in the Contingency Fund.
- Muriel Smith asked to maintain recreation centers because it might lead to increased gang activity. Ms. Smith spoke in support of raising the cost of program fees provide more revenue for community centers.
- 10. Paul Barnes spoke in opposition to proposed budget cuts regarding service or wage reductions. Mr. Barnes spoke in favor of increasing revenue.
- 11. Darlene Anaya submitted a comment card in support of keeping the community center in Lindo Park open.
- 12. Carole Henry asked to maintain recreation and senior centers. Ms. Henry stated residents in some neighborhoods had not recovered from the reductions in service that occurred in 2008. Ms. Henry suggested rotating programs through different facilities throughout the City instead of eliminating them altogether.
- 13. Jerry Clore stated all of the stakeholders in the community should face the City's budget problems together.
- 14. Major Lucious submitted a comment card that opposed reducing services that were critical to the residents' welfare.
- 15. Roy Hamilton submitted a comment card that opposed closing senior centers.
- 16. Anna Richardson submitted a comment card that opposed the closing of senior centers.
- 17. Mr. Haddad spoke in support of increasing revenue through reinstating the sales tax on food.
- 18. Nora Hamilton submitted a comment card asking to maintain senior centers.
- 19. Emilie Vazquez spoke in support of creating more dog parks and instituting a plastic bag tax.
- 20. Henry Barnwell submitted a comment card to maintain services that benefitted the youth, seniors, and other vulnerable populations throughout the City.
- 21. Michael Pops spoke in support of establishing partnerships with organizations in the private sector to develop infrastructure and programs that promote public safety. Mr. Pops suggested building a grocery store in South Phoenix.

- 22. Wannetta Davis stated the negative effects of the trial budget would have a larger impact on the residents of South Phoenix.
- 23. Libby Comer spoke in support of making larger investments in bicycle infrastructure.
- 24. Lisa Parks stated greater investments in bicycle infrastructure would activate streets, increase revenue, and make the streets safer for cyclists.
- 25. Vince Nicholes asked if Phoenix was the type of City that turned its back on its most vulnerable populations when it confronted a crisis.
- 26. Nellie Daniels submitted a comment card to maintain senior and recreational centers, and reducing aid to food assistance programs.
- 27. Michael Kelly encouraged all stakeholders in the City to participate in the budget process.
- 28. Mary Lou Mesa asked to maintain senior centers.
- 29. Jesus Rivera submitted a comment card in support of dog parks.
- 30. Frankie McMurry spoke in opposition to closing parks, pools, and recreation and senior centers for the youth and the elderly.
- 31. Bobbie McLeod spoke in support of keeping the Senior Opportunity West Senior Center open because it provided nutrition, social interaction, health and fitness education, and case management for its members.
- 32. Crystal Houston asked to maintain funding for the Arts. Ms. Houston stated minimizing the budget would drastically limit programs and restrict access to opportunities to enjoy or participate in the arts.
- 33. John Romero spoke in support of investing in bicycle infrastructure.
- 34. Gary Brauer spoke in support of developing ideas to increase revenue. Mr. Brauer spoke to maintain services at community centers, and reducing assistance to local food banks.
- 35. Jessica Beresford spoke in support of implementing methods to improve the quality of management of community centers. Ms. Bereford spoke in favor of establishing partnerships with the private and non-profit sectors to increase the caliber and number of programs available at recreational centers, and raising the cost of user fees.

- 36. Louis Acosta spoke in support of creating more efficient operational and reporting processes for the Graffiti Busters program. Mr. Acosta spoke in favor of aggressively exploring right-sourcing opportunities.
- 37. Kurt Mangum spoke in support of researching what other cities across the country were doing to increase revenue. Mr. Mangum stated it was difficult to attract new residents and businesses to an area if children were not safe or had nothing to do. Mr. Mangum spoke in favor of reducing expenses through pension reform.
- 38. Amaris Plascencia submitted a comment card in favor of establishing more dog parks in the City.
- 39. Mario Leyva submitted a comment card in support of dog parks.
- 40. Gilona Galeno submitted a comment card in support of dog parks.
- 41. Betty Ware spoke in favor of reinstituting the sales tax on food to raise revenue.

 Ms. Ware stated the proposed budget cuts would have the negatively impact the lives of the youth and seniors.
- 42. Felix Trejo asked to maintain services at senior centers.

Mr. Zuercher thanked everyone in attendance. Councilwoman Gallego thanked the residents of District 8 for their dedication and passion, and for sharing their ideas and budget priorities. Councilwoman Gallego closed the budget hearing at 8:15 p.m.

Deputy City Manager Deanna Jonovich opened the meeting at 5:39 p.m. by welcoming those in attendance, thanking them for coming to the community budget hearing and presented the video overview of the proposed budget.

Following the presentation, Ms. Jonovich stated that the Mayor and City Council look forward to hearing from residents and opened the meeting to public comments.

- 1. Mary Rose Wilcox spoke in favor of continuing funding for the senior centers in the community because of the resources they provide low income families.
- 2. Shannon Dubasik asked to maintain University Park because of the important services it provides to the community.
- 3. Mary Alvarez asked to maintain services at Marcos de Niza Senior Center and Harmon Park because of the important services they provide to low income families.
- 4. Job Salinas Hernandez spoke in support of services at Marcos de Niza Senior Center and Harmon Park because of the important services they provide to low income families.
- 5. Calistro Rosales spoke in support of services at Marcos de Niza Senior Center and Harmon Park because of the important services they provide to low income families.
- 6. Grace Arroyo Salinas asked the city to use new taxes to help fund youth services at community centers.
- 7. Raul Daniels spoke in favor of funding for youth services to keep kids off the street and out of trouble.
- 8. Ginger Baron asked to continue services at Marcos de Niza senior center, pools, and any year round recreation activities. She also stated that dog parks should close before any community center.
- 9. Arthur Murillo asked that the youth services provided by the city get its fair share of financial support and that more input from low income families was need as part of the budget process since they rely on these services so much.

- 10. David Galavis expressed concern over reductions in youth programs that help children stay out of trouble and asked the city to not fund any part of the costs to host next year's Super Bowl.
- 11. Eva O. Olivas spoke about how the community and the city should work together to resolve the budget deficit and stated that the current budget is unacceptable and hoped the city could develop a budget that did not affect so many community services.
- 12. Selena Salazar asked to maintain services at community centers because they keep the communities safer. The youth programs help kids with activities that keep them off the street. She asked the city to keep services equal throughout the city and do not concentrate on low income areas.
- 13. Peter Martin spoke about how important community togetherness was and that the city needed to work with its partners to resolve the budget deficit and keep the important services that are identified as possible cuts.
- 14. Maria Herren stated opposition to the closing of any parks, libraries, or pools during the summer because these locations are safe for kids to visit.
- 15. Stanley Johns asked the city to keep the parks open.
- 16. Gloria Gonzalez asked to maintain services at community or youth centers especially in low income areas where the services are needed the most. She asked that the city be equitable in reducing services in all communities.
- 17. Michael Stevens asked to maintain services at senior or youth centers.
- 18. Mary Chou-Thompson submitted a card asking that the city not eliminate any youth programs because they are important to the city.

Afterward, Ms. Jonovich thanked everyone for attending and providing their important input into the city's budget process and closed the Community Budget Hearing at 6:35 p.m.

Councilwoman Williams opened the community budget hearing at 6:06 p.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget. She introduced Deputy City Manager Rick Naimark and indicated the presentation would provide valuable information about the proposed budget.

Mr. Naimark gave a brief summary of the proposed 2014-15 budget and asked staff to present the overview video describing the process in more detail. Following the presentation, Councilwoman Williams opened the hearing to public comments.

- Karen Young spoke in support to maintain services at community centers and stated both seniors and children would be negatively impacted if the center was closed. She stated it would also increase the crime rate if the centers were closed.
- Jack Davis spoke in favor of leaving the Beuf Community Center open and bike safety. He supported reinstating the sales tax on food to help resolve the budget deficit.
- 3. Ronald Vaught spoke against the proposed spending cuts and stated he thought more revenue ideas would help resolve the budget problem.
- 4. Geri Bowers asked that services be maintained at community centers for seniors.
- 5. Betty VerMeer spoke in favor of keeping the Deer Valley Community Center opened.
- 6. Linda Fleur requested services continue at community centers.
- 7. Rosalie Hurd spoke in support of services at community centers and stated how important the fitness programs are for the children.
- 8. Rosa Pecaro stated seniors have contributed to the community and closing the Deer Valley Community Center would be a hardship for seniors and children.
- 9. Charles Bube spoke in support of maintaining community centers and supported finding better ways to spend city resources. He stated he is against the dog parks.

- 10. Alvin McCarty spoke in support of maintaining services at Beuf Community Center and stated persons with disabilities benefit from the centers. He asked if the City Council offices are also cutting their budgets and stated many children and seniors eat at the centers.
- 11. Miranda Cain from the Greater Phoenix Chamber of Commerce supported the proposed spending cuts and is opposed to any tax increases. She supported efforts to expand the business community.
- 12. Dawn Titles stated he had concerns about the budget and wanted to know how the city went from being structurally balanced to now showing a deficit.
- 13. Barb Heller spoke against the proposed budget and suggested increasing fees to help keep community centers opened.
- 14. Al Lauwers asked to maintain services at senior centers and stated he does not support the dog parks.
- 15. Judi Haenel spoke in support of increasing revenues to help solve the budget deficit. She stated she supports reinstating the sales tax on food and charging businesses fees. Additionally, Ms. Haenel stated she did not agree with raising the City Manager's salary.
- 16. Charles Fortner spoke in favor of reducing the number of managers.
- 17. Richard Eon spoke against the proposed budget cuts and stated spending is too high.
- 18. Barbara Eon spoke in favor of maintaining community centers and purchasing golf courses. She also spoke against the dog parks and proposed enhancements to Margaret T. Hance Park.
- 19. James Main spoke against spending by the City Council offices and the proposed budget cuts.
- 20. Ralph Battaglin asked to maintain services at the Beuf Community Center and the proposed budget.
- 21. Becky White spoke in favor of increasing revenues to keep senior centers open. She also spoke in favor of police officers and is against closing central booking.
- 22. Carol Blundall spoke in favor of keeping the senior centers open and reserve a ride. Mr. Naimark stated he would have staff follow up with Ms. Blundall regarding transportation.
- 23. Kent Snider spoke in favor or restoring the sales tax on food and other revenue increases to help resolve the budget shortfall.

- 24. Carol Trevilian spoke in favor of maintaining the Beuf Community Center.
- 25. Art True spoke in support of the community and senior centers.
- 26. Jay Caruthers spoke in support of the community centers and stated the center provides valuable services to seniors and children. He stated he is concerned about property values declining if the centers are closed.
- 27. Barbara Gonzales spoke in support of the community centers and fee increases but supports reinstating the sales tax on food. She also spoke against closing central booking and reductions to fire prevention services.
- 28. Robert Suich spoke in support of the community centers and suggested reducing salaries of top managers to help resolve the budget deficit.
- 29. Ron (no last name provided) spoke against taxes and in favor of keeping the community centers opened for seniors.
- 30. Rupesh Ratkaran spoke in favor of Beuf Community Center and the children and fitness programs offered at the center.
- 31. Friar Henry Wasielweski spoke in favor of keeping the Deer Valley Community Center open. He spoke against the proposed cuts and supports reinstating the sales tax on food.
- 32. Suzanne Day spoke in favor of bike infrastructure and public transit services. She stated she supports reinstating the sales tax on food and is also against closing community centers.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS COUNCIL DISTRICTS 4 & 8 PHOENIX CHILDREN'S HOSPITAL April 10, 2014

Councilwoman Laura Pastor opened the community budget hearing at 6:05 p.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget.

Acting Assistant City Manager Danny Murphy introduced city staff. He gave a brief overview of the budget and then presented the video describing the proposed budget in detail.

Afterward, Councilwoman Kate Gallego expressed that she does not support this trial budget. She added she promotes bike safety and infrastructure as well as personal ID cards. She opened the hearing to public comment.

- 1. Seneca Boulanger spoke to maintain services at her local park on 67th and Encanto. She and her family utilize the park to play sports and spend time.
- 2. Paul Barnes spoke against the proposed service cuts and does not support balancing the budget by reducing employee wages, which he feels would decrease morale. He proposes to increase revenue and advocates for the food tax.
- 3. John Walker spoke in favor of increased bike infrastructure and safer cycling. He would like bicycle funding to continue. Mr. Walker noted a study showing that bicyclists bring in local revenue by remaining in the area to eat and shop.
- 4. G.G. George spoke against the proposed budget but supports increased revenue options such as reinstating the sales tax on food. She also supports parks programs and its amenities stating it is a vital component to the City.
- 5. Mary Moore does not support closing her local pool and advocates for the Neighborhood Services attorneys in order to preserve local neighborhoods. She also supports bringing back the sales tax on food and finding other revenue streams.
- 6. Derek Horn supports Historic Preservation as he feels it retains stability in neighborhoods.
- 7. Richard Siever submitted a card in favor of continuing or increasing park services.

- 8. Luis Schmidt spoke against the proposed services cuts explaining that many residents rely on those services. He spoke in favor of the community centers and Ironwood pool. He is against making cuts to employee wages.
- 9. Joseph Benesh spoke in favor of the Arts programs as it is vital to investing in the children. He also supports a bag tax and bringing back the food tax.
- 10. Sandra L. Lilley submitted a card for her support of the community centers. She explained they are essential to keeping the youth occupied and off the streets. In addition, she is against any cuts to fire and police and is requesting more.
- 11. Lori Gonzalez spoke in favor of restoring the 1% on sales tax on food and extending it past its sunset date. She expressed concerns regarding the closure of senior centers, particularly in District 8.
- 12. Emelie Vazquez spoke of her support of a plastic bag tax as well as her support of a dog park in the district.
- 13. Gustave Vasquez spoke of his support for a dog park in the area.
- 14. Clarissa Felix spoke in favor of a plastic bag tax and a dog park in the area.
- 15. Charlene Tarver spoke in favor parks and recreation programs as well as Arts. She favors additional revenue resources in order retain services for children's health, safety, and welfare.
- 16. Abraham James supports the arts programs, library, transit, senior and youth centers, neighborhood services, public works, fire, and police. They are essential in order to retain the status as a world-class city.
- 17. Julie Witenstein and her daughter spoke in favor of the arts, especially for the Teen Art Guild explaining it provides youth an outlet to keep busy and increase their confidence.
- 18. Joe Murphy supports a plastic bag tax and does not support employee cuts.
- 19. Bill Cusimano supports charging for parking at popular parks and reinstate charging for metered parking after hours and weekends. He does not support cutting essential employee positions, Fire Response teams and maintenance workers. He supports additional revenue sources.
- 20. Anthony Leach supports cutting executive salaries in order to retain recreation centers and other services for his children. He also spoke in favor of increasing funding for police.
- 21. Giona Galeno spoke in favor of recreation centers, a dog park, and promoting a plastic bag tax. She stated recreation centers allow people to bond and

relieve stress.

- 22. Juana Mendoza submitted a card wishing to support dog parks and a tax on plastic bags.
- 23. Dan Carroll spoke in favor of alternative revenue such as the sales tax on food, a cellular public safety fee, mountain parks parking fee, a tax on graffiti supplies, and a plastic bag fee. He is not in favor of the proposed budget and does not favor balancing budget on the rank and file men and women.
- 24. Jennifer Boucek spoke in favor of personnel that support historic preservation as well as other employees. She supports reinstating the 1% on sales tax on food and extending it. She also expressed her hope in ensuring the budget is secure for the future instead of just temporarily.
- 25. AJ Marsden spoke in favor of the sales tax on food. She also expressed her concern with user fees as a revenue source since it could potentially hurt the ones that can't afford them. She opposes the elimination of Central Booking.
- 26. Tanya Callaway expressed her disappointment that Phoenix is not committed to a live/work/play mentality. She explained her perspective while searching possible relocation areas for herself and her small business.
- 27. Monique Lange spoke against closing the Long View Recreation Center or any other recreation center with an after-school program. She supports increasing fees up to \$150/semester if they could remain open. She also requested more activities be offered. She also supports a dog park.

Councilwoman Pastor thanked everyone for participating in the hearing and expressed her support for senior centers, fire, police, and historic preservation in her closing comments.

Councilwoman Gallego thanked everyone for their suggestions and she concluded the hearing at 7:27.

- 18. Gary Brewer spoke against all the budget cuts. Mr. Brewer spoke in favor of restoring the sales tax on food.
- 19. Ed Blunden provided information about the City's pension system.
- 20. Jane Conway did not speak but submitted a card in favor of reducing the cost of building lower income apartments and reducing pension costs to taxpayers. Ms. Conway stated she did not support the City Manager's pay or water-rate raises.

Councilman Bill Gates opened the Community Budget Hearing at 7:32 a.m. by welcoming those in attendance and thanking staff and residents for attending. He informed everyone that Councilman Daniel Valenzuela would be there shortly. He then introduced City Manager Ed Zuercher who introduced a budget overview video which described the budget process in more detail.

Following the presentation, Councilman Gates introduced Mayor Greg Stanton and thanked him for attending the hearing. Mayor Stanton thanked everyone for coming and emphasized the importance the citizens' comments have on the final adopted budget due to our hyper-public budget process. - 2. Auria and Herlinda Cerbas spoke in support of keeping the senior centers and community centers open. They suggested the increase in the City Manager's salary could have been used to support cuts.
- 3. Tee Lambert asked how the budget cuts are determined by the City. She supports and encourages creative revenue ideas.
- 4. Judy Guilds spoke in support of new revenue and does not want to see budget cuts in the arts programs.
- 5. Patsy Bauer spoke in support of keeping the Sunnyslope Community Center.
- 6. Craig Tribken supports more funding for the homeless shelters and services.
- 7. Harold Brazer spoke in support of keeping the community centers and senior centers open.
- 8. Linda Smith spoke in support of our libraries and was happy to find out library funding is earmarked from property taxes.
- 9. Sherry Rampy spoke in support of the Historic Preservation Commission.

- 16. Michelle Goings spoke in support of arts and culture to attract more people into Phoenix which would lead to increased tax revenue.
- 17. Roger Peck spoke in support of keeping the senior and community centers, swimming centers and parks open. He would like to see more of the park rangers restored from the prior year cuts.
 - Councilman Gates responded that although we have not restored all of the previously cut park rangers, we did restore some of them last budget year.
- 18. Gene Derie believes we have cut too much over the years and we must keep the centers open. He supports increasing taxes.
- 19. Walt Gray is opposed to the proposed cuts. He supports employee raises and suggests adding an increment of 0.15% to the general sales tax, but not the sales tax on food.
- 20. David Bickford spoke in support of senior centers and community centers as well as more funding for bicycle infrastructure. He would also like to see improvements on the frequency of the bus and light rail transportation system.
- 21. Michael Spano supports keeping the Sunnyslope Community Center and senior centers open.
- 22. Betsy Durkin spoke in support of keeping the community centers open.

- 23. Leslie Spencer-Snider spoke to oppose any more cuts to our parks. She supports keeping the sales tax on food and finding new revenue sources.

 - Councilman Gates clarified that the need for cuts was not entirely due to cutting the sales tax on food. The sales tax on food cut amounted to \$14 million while the total deficit was \$38 million.

- 33. Colby Jeffers spoke in favor of keeping the community centers open for our youth and teens.
- At 9:15 a.m., Councilman Gates thanked everyone for attending and left the meeting.
- 34. Suzanne Day spoke in support of keeping the community centers open. She supports keeping the sales tax on food as well as creating a plastic bag and bottle tax. She also supports bicycle infrastructure and public transportation improvements.
- 35. Mike Stewart spoke in support of keeping the Sunnyslope Community Center open.

- 36. Carey Mavin spoke in support of keeping the Sunnyslope Community Center open.
- 37. Benjamin Spano spoke in favor of keeping the Sunnyslope Community Center open.

The following individuals did not speak, but attended the meeting and submitted comments:

Valley Leadership Executive Director Christy Moore opened the Community Budget Hearing at 7:55 a.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget. Ms. Moore introduced guest Rick DeGraw, Executive Vice President of CopperPoint Mutual Insurance Company, and she thanked CopperPoint for hosting the community budget hearing.

Ms. Moore introduced City Manager Ed Zuercher. He gave a Powerpoint presentation of the proposed 2014-15 budget. Mr. Zuercher also stated, due to feedback from previous budget hearings, the City Council would be discussing upcoming revenues sources at a future city council meeting.

Mr. Zuercher opened the hearing to public comments.

SUMMARY MINUTES COMMUNITY BUDGET HEARINGS CITYWIDE ONLINE WITH MAYOR STATON PHOENIX CITY HALL APRIL 22, 2014

Mayor Greg Stanton opened the community budget hearing at 6:05 p.m. by welcoming those in attendance and thanking them for coming to comment on the City's proposed budget. He described the format of the meeting which would include both live comments from those in attendance and comments submitted online through email, Twitter or Facebook. Mayor Stanton explained this was the last of more than 20 budget hearings held this year. He stated City Manager Ed Zuercher would propose a revised budget on which the City Council will vote on.

Mr. Zuercher provided a presentation which gave details on the city's budget process, fiscal year 2014-15 revenue & expenses and proposed reductions. He stated the City Manager's Proposed Budget will be presented on May 6th for City Council consideration and formal action two weeks later on May 20th.

Mayor Stanton asked why Mr. Zuercher is recommending an increase to the city's contingency fund in light of the budget situation. Mr. Zuercher responded the rating agencies which give the city a credit score expect to see 5% of operating funds in the contingency fund. He added that the city contingency fund is currently below 4% and the recommendation would be to continue to increase it until it reaches at least 5%. He explained that other valley cities have contingency funds above 5%.

Mayor Stanton opened the meeting to public comments.

- 1. Walt Gray commented he is does not support reinstating the sales tax on food although he does support new revenue with taxes on non-necessities.
- 2. Wally Graham commented he would like to see the budget balanced by increasing revenue through development fees and without eliminating any city services.
- 3. Dennis Mareiro commented he does not want the budget to be balanced entirely through reductions to city employee wages and benefits.
- 4. Cecilia Marie commented through email she does not support a sales tax on food or an increase to city employee salaries and pensions.
- 5. Tom Henderson commented through email he supports the sales tax on food because it would help maintain city services like community centers.

- 6. Kenneth and Suzzane Jordan commented through email they do not support the sales tax on food or any new taxes.
- 7. Jesse Hardeman commented as an employee for the city he has not seen any raise to his salary and has seen an increase to medical expenses. He stated he would like to see a reduction to upper management compensation. Mr. Zuercher responded the City Manager's staffing has been reduced by 40% in the last five years. He stated middle managers and executives have only received an increase to their compensation once in the last five years. He concluded that any reduction to employee compensation will also apply to upper management positions.
- 8. Luis Schmidt stated he supports additional revenue options and considering the amount of out of state real estate investors, he would like to see an increase to property rental fees.
- 9. Doug Arnold commented on Facebook he would like to see new revenue sources instead of closing pools and senior centers.
- 10. Drew Gomez asked on Facebook where all the revenue from gaming casinos goes to. Mayor Stanton responded because of agreements with the surrounding tribal nations the city receives minimal gaming revenues and therefore it is not a viable solution to the city's budget deficit.
- 11. Phoenix Center for the Arts commented on Facebook any budget reduction to arts programs will have a negative impact for at-risk and underserved communities.
- 12. Richard Santos commented he supports fee increases to continue city operations and eliminate the need for reductions.
- 13. Abe Arvizu Jr. commented he would like to see an increase to revenue and recommends a junk food tax or a tax on items that are not a necessity.

Mayor Stanton asked Mr. Zuercher whether eliminated vacant positions would help balance the budget. Mr. Zuercher responded that due to budgeted vacancy savings, cutting vacant positions would reduce the budget somewhat while impacting services and still requiring further actions to eliminate the deficit.

14. PhxDowntowner commented through Twitter they would like to see a fee increase for pools and community centers with non-resident fees being higher than for residents.

- 15. Physpokespeople commented through Twitter that bike lanes cost less and create more jobs than road only projects.
- 16. Esqaz commented through Twitter that parks and open space is key to maintaining quality of life in Phoenix.
- 17. Oparide requested through Twitter more public restroom facilities for downtown Phoenix.
- 18. Marshall Pimentel commented he would like to see new revenue including the food tax being reinstated and would like to see any cuts to employees also include Public Safety departments to make it fair across the board.
- 19. Steven Vollmer commented through email in support of funding for parks and no reductions to amenities which are already in place.

- 143. Mike Goers sent an email for clarification on how merit and productivity enhancements build from one year to the next. Budget and Research staff responded to his email.
- 144. Monica Goings sent an email in support of increasing revenue including the sales tax on food.
- 145. Lynne Johnson submitted a petition with 46 signatures in support of maintaining services at senior centers and Telephone Pioneer Park Pool.
- 146. Jenny Stahl sent an email in support of maintaining services at community centers and pools.
- 147. Charles Kaplan sent an email in support of maintaining services at Desert West Community center.
- 148. Gary Jordan sent an email in support of maintaining CERT.

The additional comments are provided below.

Additional Comments Mayor's Online Budget Hearing April 22, 2014

- 1. Christopher sent an email suggesting the City raise revenues. He added the City should increase fees at community centers and bicycle registration fees however not the food tax.
- 2. Ann Bogart sent an email suggesting street striping and traffic signals be privatized, and to privatize other departments and/or eliminate others. Additionally she commented no one should be allowed a full pension without 30 years of service and the city should not allow employees to collect until they are 65 years old. Lastly, she suggested a 50-50 employer-employee split.
- 3. Ashely Dechter sent an email to maintain funding for homeless programs noting a reduction is contradictory in assisting the City's goal to end homelessness.
- 4. James Emge sent an email in support of maintaining fire prevention and crisis response programs noting the importance of being prepared as Phoenix continues to grow.
- 5. Kristina Pham sent an email in support of maintaining services at the community centers, especially the Sunnyslope Community Center.
- 6. Jack Ranby sent an email suggesting the City raise property taxes enough to balance the budget.
- 7. Mary Pat sent an email noting closing community centers would be devastating.
- 8. Bruce Mckinstry sent an email to not fund downtown parks at the expense of basic services such as police and fire protection.
- Pat Mckinstry sent an email asking the Mayor to lead a majority vote against the proposed budget. She asked the City to reprioritize the budget.
- 10. Mary Lynne Herr sent an email stating she was against reducing city services. She asked to reinstate the sales tax on food.
- 11. Traci Benstine sent an email suggesting stiffer penalties for garbage in yards, outreach programs can receive help with xeriscaping yards and

- clean up. She also suggested using the canal clean up as community service and stronger police presence.
- 12. Karla Roberts sent an email asking Mayor Stanton to not balance the budget on the backs of employees but to find another way. She added the City is too top heavy and the budget staff that mismanaged funds should be fired.
- 13. Janessa Gonzales sent an email asking to not reduce City services and to stop attacking employees and their pay.
- 14. Alice sent an email stating look at the wealth being funneled everywhere and asked why the city does not have its share to keep in the community where it is being spent. Additionally she questioned reinstating the sales tax on food.
- 15. Gene Wikle sent an email to maintain support for Central Arizona Shelter Services. He questioned how the City justifies such a reduction of services to the citizens who need it the most vulnerable.
- 16. Neal Haddad sent an email stating that the City Manager did not suggest the sales tax on food as a revenue option. He added the entire budget process is a travesty as it effectively marginalizes citizen involvement in finding a solution. He also stated the planned spending was too aggressive based on an exuberant forecast in revenue. He asked to reinstate the sales tax on food.
- 17. Tim O'Malley sent an email saying the City made a commitment to serve the homeless and to keep safe the neighboring areas around the shelter.
- 18. Breaktofix sent an email noting the City was balancing the deficit on employees' backs, yet noting the City Manager's salary. He stated he hopes that people think about what they are doing and how many people will be affected by the choices.
- 19. Evert Andersen sent an email with the following suggestions
 - Cut all city officers and employees wages by 5% as many of those who work outside of government received a cut in hours and a 10% cut.
 - Zero in on traffic violations such as driving on out of state plates and living here.
 - Fines for load radios.
 - Fines for non-muffled vehicles.
 - More radar and higher fines for speeders.
 - Cut down on the bulk trash pick up to once every six months.
 - Cut back on the purchase of vehicles by driving the vehicles an extra two years.

- Simplify the water bills to a simple post card cutting stationary costs.
- Eliminate street lights where there are frontage roads with lights.
- At 35th Ave and Cactus area, there are many duplications of street lights.
- 20. Jodie Snyder sent an email in support maintaining tennis classes at Encanto Park.
- 21. Richard Rea sent an email stating he strongly believes that the current budget (and those for several years to come) should be increased to cover those projects that have been delayed, cancelled or just underfunded. He added it is neither the current Council nor the workers for the city of Phoenix causing the current problem. He commented without a significant source of future funding, it will be almost impossible. Lastly, he stated we all have to roll up our sleeves, pitch in, pay more and pay for the services that our citizens need and deserve.
- 22. Trish McCarty sent an email to consider any programs having to do with youth engagement, especially military working with the kids to learn on-the-job-training. She added we could accomplish job training and perform needed city work by enlisting our kids.
- 23. Bill Cusimano sent an email asking the Council to ask employees for their input on the budget and suggested changes. He added the City may be surprised at the sacrifices that employees may be willing to make, however he suggested that there needs something that is fair to all.
- 24. Dave Drake sent an email suggesting the following reductions
 - An 10% reduction in government salaries for any amount over \$100,000; Frank Fairbanks was never paid this and the City was better run.
 - A 10% tax on all government salaries over \$100,000.
 - Outsource items like changing oil and routine maintenance on government vehicles to save money.
 - Reduce redundancies in overlapping regulations and work processes within the government
- 25. Katie McClure sent an email stating she was disappointed about the cut to the sales tax on food and the potential impact of closing senior centers and pools. She asked that the City do something to rectify the situation.
- 26. Ryan McClure sent an email stating cutting the sales tax on food was not in the City's favor. He added balancing the budget by cutting the community and employees does not fix the problem of bad decision-making.

- 27. Bert Aldieiri sent an email suggesting identifying City services that offer low value to residents or offer services that can be served by the private sector and remove them from the budget. He added we also need to provide incentives to business growth in our city.
- 28. Susan Rajchel sent an email strongly opposed to the sales tax of food.
- 29. Caroline Condit sent an email strongly opposed to the sales tax on food.
- 30. Sam Oliver sent an email saying it is not right to balance your budget on the tax payers and your City employees. He asked to fix the budget in a different way as it is the City's management of funds that have caused this budget problem in the first place.
- 31. Joseph Caiola sent an email asking the City to say no to the sales tax on food, union workers and city employee salary and pension increases.
- 32. Steve Vollmer sent an email asking the Council to vote yes to maintain funding for Encanto Park.
- 33. Tom Cox sent an email to maintain funding to ensure elderly & under privileged are not short changed.
- 34. Helen Burland sent an email to raise alarm fees to \$15 annually and increase dog license fees.

She added of particular concern for my neighborhood are those reductions that would have a significant impact on our beloved, beautifully renovated Encanto Park. Lastly she stated she would like to see the city food tax restored.

 - NO to big spenders, live within our means.
 - NO to the FOOD TAX
 - NO to Union Workers and City Employees salary & pension increases while pools, libraries, and senior centers are CLOSED down due to lack of funds.
- 37. Lynn Remelski sent an email stating she wants the city to live within its means.

- 38. Suzanne Jordan sent an email stating no on the sales tax on food. She added Phoenix needs to live within its means.
- 39. James Shoat sent an email commenting against employee pay reductions.

If you decide to charge a bag tax, we will bring our own bags, if you raise water rates we will haul in our own water. Stop with bad budgeting decisions.
