

EARLY VOTING INSTRUCTIONS

ENCLOSED IS A THREE-PAGE, TWO SIDED BALLOT.

PLEASE CAST YOUR VOTE ON THE FRONT AND BACK OF THE FIRST BALLOT PAGE.

YOU ONLY NEED TO RETURN THIS PAGE OF THE BALLOT INSIDE YOUR AFFIDAVIT ENVELOPE.

THE SECOND AND THIRD BALLOT PAGES CONTAIN THE FULL TEXT FOR PROPOSITIONS 102 AND 103. YOU DO NOT NEED TO RETURN THESE BALLOT PAGES IN THE AFFIDAVIT ENVELOPE.

- Use blue or black ink to mark one choice for each office or proposition on the ballot as shown in the instructions below. Do not make any stray marks on the ballot.
- Look at both sides of the ballot for offices or propositions.

TO VOTE

- For each office or measure, complete the arrows pointing to your choice with a single bold line.
- Do not write a candidate's name in the "Write In" area if it already appears on the ballot.

TO CAST A WRITE-IN VOTE

- Print the write-in candidate's name on top of the shaded text in the space provided on the ballot. Only votes cast for a certified write-in candidate will be counted.
- Complete the arrow pointing to your write-in vote.

- You are not required to cast a vote for all offices or propositions. The remainder of your ballot will still be counted.
- If you vote for more than one candidate for an office or both YES or NO for a proposition, it is an over-vote. The vote will not be counted for that office or proposition, but the remainder of the ballot will be counted.
- If you make a mistake, damage or misplace your ballot, call the City Clerk Department at (602) 261-VOTE (8683) to request a new ballot. Do not try to correct a mistake on the ballot.
- **Sign the ballot affidavit in the space provided.** For your protection, the signature on this affidavit is compared to the signature on your voter registration record. Please sign the affidavit the same way you sign legal documents. **The affidavit envelope MUST be signed for your ballot to be valid and counted.**

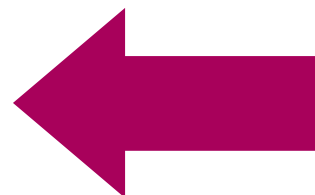

- Place the ballot inside the signed affidavit envelope, seal it, and mail it. Postage is paid by the City.
- **For the ballot to be counted, the signed affidavit envelope containing the ballot must be RECEIVED by the City Clerk Department, or delivered to ANY voting location, not later than 7:00 p.m. on Election Day.** Be sure to mail your ballot early enough to allow sufficient time for delivery by the deadline. The United States Postal Service advises that first class mail will be delivered 3 to 5 days after it is sent. Ballots must be **received**, not postmarked, by 7:00 p.m. on Election Day.
