

### **Proof of Identity: Phoenix City Services Card**

Proof of identity. An applicant must present a minimum of two of the following identity documents. At a minimum, one document must display a current photograph of the applicant, and one document must display the applicant's date of birth. A document that demonstrates the applicant's identity must be in English, an original or a certified copy as certified by the issuing agency, and if applicable, the document must not be expired. If the applicant's current legal name is different from the identity document, the applicant must submit proof of a lawful change of name.

- Enhanced Driver License or enhanced ID card issued by any state in the U.S.; or
- Enhanced Tribal Card (Tohono O'odham Nation, Kootenai Tribe and Pascua Yaqui Tribe); or
- Birth Certificate issued by any state, territory or possession of the U.S. (excluding hospital records/certificates and abstracts of birth); or
- Delayed Birth Certificate issued by any state, territory or possession of the U.S.; or
- U.S. Certificate of Birth Abroad (FS-240, 545 or DS-1350); or
- U.S. Passport or Passport Card; or
- Arizona ID Card; or
- Tribal Certificate of Indian Blood; or
- Tribal or Bureau of Indian Affairs Affidavit of Birth; or
- Foreign Passport (Excluding passports from countries subject to OFAC Sanctions); or
- I-94 Form with photo or other acceptable form of state identification; or
- Permanent Resident Card/Resident Alien Card, I-551; or
- USCIS Employment Authorization Card (EAC), Excluding an EAC with category codes A11 (Deferred Enforced Departure) or C14 (Deferred Action); or
- Refugee Travel Document; or
- U.S. Certificate of Naturalization; or
- U.S. Certificate of Citizenship; or
- U.S. Military DD-214; or
- U.S. Military ID Card (Active Duty, Reserve or Retired); or
- Record of a previous Arizona Driver License, ID Card or Instruction Permit; or
- Affidavit of Identification from the Arizona Department of Corrections (with photo and presented within 15 days of issue); or
- Released Offender ID from the Arizona Department of Corrections (with photo); or
- Alpha Program/Community Re-Entry ID from the Maricopa County Sheriff's Office; or
- Affidavit of Identification (with photo and presented within 15 days of issue); or
- Voter Identification Card issued by the Federal Government of a Foreign Country (Excluding countries subject to OFAC Sanctions);

- Photo identification card issued by the federal government of a foreign country (Excluding countries subject to OFAC Sanctions) That meets all of the following requirements:
  - I. The issuing country authorizes the use of the card as an alternative to a passport for re-entry into the issuing country; and
  - II. The card has a photograph of the applicant and the applicant's date of birth; and
  - III. The card meets standards established by the program administrator to ensure that (1) the applicant was required to provide reliable identifying information in order to obtain the card; and (2) the card has features reasonably designed to protect against fraud and counterfeit reproduction; or
- Driver License, ID Card or Instruction Permit issued by any state, territory or possession of the U.S.; or
- Arizona Certificate of Birth (Foreign Born); or
- U.S. Social Security Administration Card; or
- U.S. Military Dependent ID Card; or
- U.S. Armed Forces Driver License; or
- U.S. Department of Veterans Affairs Card; or
- U.S. Department of Justice Inmate ID Card; or
- U.S. Motor Vehicle Record or Clearance Letter (Within 30 Days of Issue); or
- U.S. Selective Service Card; or
- W-2 Form issued by an Employer in any State, Territory or Possession of the U.S.; or
- Concealed Weapons Permit Issued by Any State, Territory or Possession of the U.S.; or
- Medical Insurance ID Card (Including AHCCCS ID Card) issued by any state, territory or possession of the U.S.; or
- Professional license issued by any state, territory or possession of the U.S.; or
- Bank Card issued by a bank that does business in any state, territory or possession of the U.S.; or
- Credit Card issued by a bank that does business in any state, territory or possession of the U.S.; or
- Employee ID Badge (with photo) issued by an employer in any state, territory or possession of the U.S.; or
- School ID (with photo) issued by a school in any state, territory or possession of the U.S.; or
- Marriage Certificate issued by any state, territory or possession of the U.S.
