



IMPORTANT DATES SPECIAL ELECTION NOVEMBER 6, 2018

TBD (AS SOON AS VACANCY OCCURS)

- Earliest date for potential candidates to receive Candidate Packet and file Declaration of Candidacy Form with the City Clerk.
- Earliest date for elector to sign petition for nomination.

TBD (WITHIN 10 DAYS OF VACANCY)

- Latest date for potential candidates to file Declaration of Candidacy Form with the City Clerk.

MAY 27, 2018 (SUNDAY)

- Earliest date to request an early ballot. *A.R.S. 16-542*

JULY 9, 2018 (MONDAY)

- Earliest date for presentation of nomination petitions to the City Clerk. *City Charter, Chapter XII, Sec. 2*

AUGUST 8, 2018 (WEDNESDAY)

- Latest date to present nomination petitions to the City Clerk. *City Charter, Chapter XII, Sec. 2*
- Latest date to file arguments supporting or opposing any propositions. *City Code Sec. 12-403*

AUGUST 18, 2018 (SATURDAY)

- Latest date for the City Clerk to prepare list of names of candidates who have filed petitions, except candidates who have withdrawn or died or are otherwise disqualified. *City Charter, Chapter XII, Sec. 7*

AUGUST 23, 2018 (THURSDAY)

- Latest date to withdraw name from nomination by filing with the City Clerk. *City Charter, Chapter XII, Sec. 4*

AUGUST 27, 2018 (MONDAY)

- Expected latest date for the City Clerk to certify list of candidates.

SEPTEMBER 27, 2018 (THURSDAY)

- Latest date for write-in candidates to file nomination papers with the City Clerk. *City Code, Sec. 12-1103*

OCTOBER 9, 2018 (TUESDAY)

- Latest date to register to vote in Special Election. *City Code, Sec. 12-106*

OCTOBER 10, 2018 (WEDNESDAY)

- Early voting begins/early ballots mailed. *A.R.S. 16-542*

OCTOBER 26, 2018 (FRIDAY)

- Latest date to request an early ballot by mail. *City Code, Sec. 12-903*

NOVEMBER 2, 2018 (FRIDAY)

- Latest date to vote early at an early voting location. *City Code, Sec. 12-907*

 **NOVEMBER 6, 2018 SPECIAL ELECTION**

The election will be conducted by Maricopa County as part of the General Election. Voters who choose to vote at the polls must vote at their designated polling place near their home. Polling places will be open from 6 AM to 7 PM only on Election Day, November 6, 2018. Voting Centers will not be used for this election. Election results will be available on November 6 beginning at 8 PM on Phoenix.gov/Results, Cox cable channel 11 and 1011, and CenturyLink Prism TV channel 8005.

NOVEMBER 21, 2018 (WEDNESDAY)

- Expected date the Council shall meet as the Canvassing Board to announce and declare the results of the election. *City Charter, Chapter XIII, Sec. 1.*
The date of the canvass will depend on the completion of ballot tabulation by Maricopa County.

RUNOFF ELECTION DATES (IF NECESSARY)

If no candidate receives a majority of all votes cast for an office in the Special Election held on November 6, 2018 the two candidates with the highest vote count will be placed on a Runoff ballot. *City Charter, Chapter XII, Sec. 16.*

FEBRUARY 11, 2019 (MONDAY)

- Latest date to register to vote in Runoff Election. *City Code, Sec. 12-106*

FEBRUARY 13, 2019 (WEDNESDAY)

- Early voting begins/early ballots mailed. *A.R.S. 16-542*

MARCH 1, 2019 (FRIDAY)

- Latest date to request an early ballot by mail for the Runoff Election. *City Code, Sec. 12-903*
- Latest date to submit challenger names to City Clerk. *City Code, Sec. 12-210*

MARCH 8, 2019 (FRIDAY)

- Latest date to vote early at an early voting location. *City Code, Sec. 12-907*

 **MARCH 12, 2019 RUNOFF ELECTION (IF NECESSARY)**

Voting begins at voting center locations on Saturday, March 9, 2019 and continues on Monday, March 11 and Tuesday, March 12. Election results will be available on March 12 beginning at 8 PM on Phoenix.gov/Results, Cox cable channel 11 and 1011, and CenturyLink Prism TV channel 8005.

MARCH 27, 2019 (WEDNESDAY)

- Latest date the Council shall meet as the Canvassing Board to announce and declare the results of the election. *City Charter, Chapter XIII, Sec. 1*
