Agenda

Request to Speak

The public may request to address the Council regarding an agenda item by submitting a yellow "Request to Speak" card at the meeting, or may submit a white card to state their support or opposition to an item for the record without speaking. The City Council will take action on most items on the agenda in one motion early in the meeting unless the item involves a public hearing or discussion has been requested. Individuals wishing to speak or submit their position on an item should arrive and submit a card by the beginning of the meeting, before action is taken on the item. Cards will not be accepted after action has been taken on an item.

Citizen Comment Session

A Citizen Comment Session, at which any member of the public may comment on issues of interest or concern to them, will be held 15 minutes prior to the start of the regular Formal Meeting and, if necessary, immediately after adjournment or recess of the Formal Meeting. Members of the public will be called to speak in the order in which requests to speak at Citizen Comment are received at the meeting. Individuals who are not called to speak before the Formal Meeting will be called to speak after the meeting. A quorum of the City Council may or may not be present. In either event, no decisions will be made and no action will be taken on any issue raised.

Accommodations

An assistive listening system is available in the City Council Chambers to assist individuals who are deaf or hard of hearing. Headset units for this system are available at the front table in the Council Chambers.
