City of Phoenix New Post-Construction Program Being Developed

The City of Phoenix (City) has a Municipal Separate Storm Sewer System (MS4) Permit, which is required by the federal Clean Water Act and issued by the Arizona Department of Environmental Quality (ADEQ).

- The MS4 Permit authorizes discharges from the City's stormwater infrastructure into surface waters like the Salt River.
- Effective July 1, 2021, the city is operating under a new MS4 Permit which requires the implementation of new programs and practices and the expansion of existing program elements.
- Non-compliance by the City with the MS4 permit could result in notices of violation, fines, and the potential for increased oversight and more prescriptive requirements from ADEQ and the U.S. Environmental Protection Agency.

Post-construction stormwater controls are used to limit surface runoff and reduce pollutant loadings and include features such as retention/detention basins, drywells, green stormwater infrastructure, and stormwater pretreatment devices.

New post-construction program requirements in the MS4 permit require the City to implement a program to inventory, track, inspect, and confirm adequate maintenance of post-construction stormwater controls.

The new elements of the post-construction program are being phased in and may include the following:

- The development of a Maintenance Plan (Operations & Maintenance Plan) for submittal with the Stormwater Pollution Prevention Plan (SWPPP).
- Inspection of post-construction stormwater controls within one year following construction.
- City audits of inspection and certification paperwork, addressing post-construction control complaints, and conducting enforcement when necessary.
- Modification of Phoenix City Code and City Stormwater Policies and Standards to incorporate finalized program requirements.
