*Citizens Commission on Salaries for Elected City Officials

The City Charter Chapter III, Section 12 requires the City Council to appoint a Commission on Salaries for Elected Officials every four years during the same year a regular election for Mayor is scheduled.

The Commission is required to conduct a review of the rates of pay of elected City officials. The purpose of this review is to determine a recommendation of pay levels appropriate to the duties and responsibilities of city elected officials. The Commission must submit to the City Clerk, no later than April 1, 2024, a report of the results of the review and its recommendations.

The Commission's salary recommendations must be certified by the Commission to the City Clerk. If the Commission recommends a salary increase, the City Council shall submit the question to the qualified electors at the next regular municipal election for their approval or rejection. In the event the Commission recommends no change in salaries for the elected officials, it shall file such recommendation of no change with the City Clerk and no question shall be submitted to the electorate.

The Commission is composed of a Chair plus six residents to serve a term not to exceed three months.

*The Commission is composed of seven residents to serve a term not to exceed three months. A Chair will be selected among the Commission members.
