**CAMPAIGN FINANCE REPORTING SCHEDULE**

**REGULAR ELECTIONS FOR MAYOR & CITY COUNCIL ARE HELD IN NOVEMBER OF EVEN YEARS WITH ANY RUNOFF IN MARCH OF ODD YEARS.**

CANs must file Campaign Finance Reports until terminated. CANs must file Annual Campaign Finance reports each Election Year other than the Election Year of the 2nd (General) Election. CANs must file Quarterly Campaign Finance reports during the 4 quarters comprising the 12 month period of the Election Year in which the City's Regular 2nd (Runoff) Election may take place. The City's Regular Runoff Election is the 2nd Tuesday in March of odd numbered years. An Election Year is defined as the 12-month period beginning on April 1 through the following March (Phoenix City Code Section 12-1504). A campaign finance report is a record of the contributions received and expenses made by a political action committee or candidate committee required for reporting financial activity. (A.R.S. Title 16, Ch. 6)

**Primary or 1st Election Date: November 7, 2028 | General or 2nd Election Date: March 13, 2029**

**Mayor & Council Districts 1, 3, 5 & 7**

**Election Year: April 1, 2028 thru March 31, 2029**

**Reporting Period:** The time frame during which contributions were received and/or expenses were paid.

**Filing Period:** The time frame to submit the report. The last date of this time frame is the due date. All reports filed after the due date accrue late fees until the report is filed. \*If the due date falls on a weekend or a holiday, the report is due the next business day.
