	PACs must file Campaign Finance Reports until terminated. PACs must file Quarterly Campaign Finance reports if there's no City of Phoenix election. If there is a City of Phoenix election in a quarter, pre-election and post-election reports are due instead. The City's Regular Runoff Election is the 2nd Tuesday in March of odd numbered years. An Election Year is defined as the 12-month period beginning on April 1 through the following March. (Phoenix City Code Section 12-1504.) A campaign finance report is a record of the contributions received and expenses made by a political action committee or candidate committee required for reporting financial activity. (A.R.S. Title 16, Ch. 6)
