

**RESULTS OF PUBLIC MEETING

ETHICS COMMISSION**

Pursuant to A.R.S. Section 38-431.02, notice is hereby given to the members of the **ETHICS COMMISSION** and to the general public, that the **ETHICS COMMISSION** held a meeting open to the public on **June 18, 2026, at 3:00 p.m.**

The results of the meeting are as follows:

**CALL TO ORDER/ROLL CALL**

The Commission was called to order at 3:02 p.m.

**APPROVAL OF MEETING MINUTES FROM APRIL 16, 2026**

This item was approved.

**STAFF UPDATE**

The item was discussed.

**INQUIRY REVIEW PROCESS**

Commission motioned to request the Commission's Counsel, in collaboration with City staff, to draft an amendment to the Commission's Rules of Procedure that removes the notarization requirement, while keeping an attestation with the penalty of perjury language and reviewing the sanctions language. The motion passed by a 4-0 vote.

Commission motioned to amend the Rules of Procedure to allow electronic submittal and signature of complaints. The motion passed by a 4-0 vote.

Commission motioned to request the Commission's Counsel, in collaboration with City staff, to draft an amendment to the City Ordinance that specifically addresses and allows a Complainant to withdraw a complaint within a specific number of days. The motion additionally requests the Commission's Counsel to work with City staff to identify a recommended number of days, based on other jurisdictions. The motion passed by a 4-0 vote.

Commission motioned to recommend the City Council makes no change to the current financial penalty language. The motion failed by a 3-1 vote.

Commission motioned to make no recommendation to the City Council regarding the current financial penalty language for frivolous complaints. The motion passed by a 4-0 vote.

Commission motioned to request the Commission's Counsel, in collaboration with City staff, to draft language regarding the appearance of impropriety. The motion passed by a 4-0 vote.

Commission motioned to request the Commission's Counsel, in collaboration with City staff, to identify and recommend appropriate locations to document the proposed amendments discussed today, including within the City Ordinances, Rules of Procedure, etc. The motion passed by a 4-0 vote.

*Per City Code Section 2-53, based on recommended changes to the Rules of Procedure made by the Ethics Commission, staff and Commission's Counsel will draft the proposed language for the City Manager for review and recommendation to Council.*
