

## **Arizona Canal Conveyance Channel**

On April 3, 2025, Neighborhood Services Department (NSD) staff coordinated an outreach and cleanup effort at the Arizona Canal Conveyance Channel near 41st Avenue and Beardsley Road. Site visits revealed encampments, including abandoned shelters and debris, as well as two tents and makeshift shelters. Despite multiple outreach attempts, no individuals accepted services. NSD staff informed Maricopa County Flood Control (MCFC), the landowner, and collaborated with Cactus Park Precinct Police to ensure safety while MCFC completed the cleanup.

#### 2025-2029 Consolidate Plan - Public Review and Comment

The draft five-year (2025-2029) Consolidated Plan, which includes the Annual Action Plan for 2025-2026, was posted for public review and comment from April 4 to May 9, 2025. Comments on the draft five-year Consolidated Plan will help prioritize decisions for federally funded programs, share the development needs in our community and make a difference for affordable housing.



# Thrive Phoenix Bell Road Clean-Up

On April 5, 2025, NSD staff supported the monthly Thrive Phoenix cleanup on Bell Road. Thirteen volunteers focused on cleaning the streets and bus stops along Bell Road from the Black Canyon Highway frontage road to 7th Avenue. Special attention was given to the 19th Avenue area, which is the focus area for the Bell Road Crime Safety Plan.





#### **Bell Road Business Alliance**

On April 15, the Neighborhood Services Department (NSD) assisted in the coordination of the monthly Bell Road Business Alliance meeting that took place at the Gamers Guild. Participants were provided with an update on the collaborated efforts with NSD, Phoenix Police Department, Arizona Department of Transportation (ADOT), Office of Homeless Solutions (OHS), and the City Manager's Office to address concerns with the I-17 and Bell Road underpass and to share information about the Community Safety Plan (CSP).





# **Community Safety Plan - Community Clean-Up**

On April 12, 2025, Neighborhood Services Department (NSD) staff facilitated a community clean up in partnership with C28 Business Alliance, 27 Collab and the Cactus Park Police Precinct. The cleanup was one of four scheduled along the 27th Ave Corridor Community Safety Plan (CSP). Volunteers focused on removing debris from 31st Avenue to 28th Drive, Sweetwater Avenue to Cactus Road. Over 50 volunteers from Calvary PHX, Grand Canyon University, and neighbors from the surrounding area participated including Vice Mayor O' Brien. Neighborhood Services Department staff coordinated with the Public Works Department for use of two 40-yard dumpsters and a tool trailer. The dumpsters were filled with 4.35 tonnage of debris that was removed from the neighborhood. NSD staff assisted with the removal of larger discarded items in alleys. In addition, Community Action Officers from the Cactus Park Police Precinct were present and provided support to ensure volunteers were safe.







#### **Love Your Block**

On April 15, 2025, the Neighborhood Services Department (NSD) Love Your Block grant application opened and the deadline for neighborhood groups to apply is May 12. Eight neighborhood groups will be awarded up to \$5,000 for a community project. This grant cycle, four of the eight grants will be awarded to projects that have a water conservation component.

## **Problematic Easement Interdepartmental Coordinator Meeting**

On April 17, 2025, Neighborhood Services Department (NSD) staff coordinated an on-site meeting at 23rd Avenue and Williams Drive to assess the easement along 23rd Avenue. The meeting was attended by Street Transportation Department, Black Mountain Precinct Community Action Officers, Office of Homeless Solutions, NSD staff and one of the business owners in the area. Street Transportation Department staff will extend the barricades on both ends of the easement to prevent people from accessing the area and illegally dumping items. They will also clean up debris, remove vegetation, and level out dirt mounds that currently are used to hide encampments from view. NSD staff will provide business owners the use of "No Trespassing" stencils and will assist with graffiti removal.







# **Cactus Park Precinct Coffee with a Cop**

On April 30, 2025, Neighborhood Services Department (NSD) staff participated in the Cactus Park Police Precinct Coffee with a Cop at Ronnie's Café. NSD staff presented information on the Street Transportation Department's Yard Sign pilot program, Block Watch Boot Camp Grant Training, and the upcoming Unveiling Celebration of the Botanical Canopy at Cortez Park on Saturday May 10, 2025. NSD also staff answered questions from the residents.



## **Neighborhood College Block Watch Grant Boot Camp Training**

On April 30, 2025, Neighborhood Services Department (NSD) staff hosted a Block Watch Grant Boot Camp training for new neighborhood organizations at the Devonshire Senior Center. Twenty-five residents attended the hybrid training to learn fundamental information on how to apply for block watch grants for crime and safety prevention. NSD staff coordinated and facilitated the training provided by the Black Mountain Community Alliance and the training was a part of "Neighborhood College", a community education program offered in-person and virtually, that features hands-on learning experiences presented by multiple city departments and external partners. The intent of the program is to provide each participant with knowledge about the city's programs, services and resources; the tools to access those resources; and the skills and ideas with which to build positive, sustainable communities. There will be another Block Watch Grant Boot Camp training on November 12, 2025, at 6 p.m. at the Washington Activity Center.



# **Impact Volunteer Awards Ceremony**

On April 30, 2025, Neighborhood Services Department (NSD) staff attended the 2025 Impact Volunteer Awards Ceremony. NSD nominees for the Impact Awards - St. Vincent de Paul's (SVdP) Neighborhood Brigade and an NSD Volunteer Austin Salkowski -- received awards for their service in the community in 2024. The ceremony took place at the Burton Barr Central Library.

#### COMMUNITY DEVELOPMENT BLOCK WATCH GRANT

**Project Title:** Housing for Hope Safe House

**Project Description:** The project will acquire a single-family home to be to use as a safe house for pregnant women, and their children, escaping emotional and/or physical domestic violence. The project is a partnership with Housing for Hope, Inc., a subsidiary of Catholic Charities Community Services, and it is funded with \$600,000 of Community Development Block Grant from NSD.

**Project Update:** During April 2025, the agency identified a property and made an offer to purchase. The offer was accepted by the property owner. Soon after, the agency worked with NSD staff to begin the inspection, appraisal, and required compliance paperwork.
