

## **Gated Alley Program and Solid Waste Relocation Petition**

The GAP provides homeowners whose properties are adjacent to an alley the opportunity to submit an application and petition signed by the adjacent property **owners** (not renters) to the city requesting both the relocation of solid waste services from the alley to curbside, and permission to install locked gates at the ends of the alley adjacent to their properties. The program requires petition signatures of 50%+1 of the property owners adjacent to the alley. **Petition signatures of all owners with garages or carports accessed by the alley must be obtained and will be included in the 50% +1 requirement**. Please note: Obtaining signatures does NOT guarantee that you will receive gates or Solid Waste service relocation.

## **PETITION**

WE, AS THE PROPERTY OWNERS ADJACENT TO THE ALLEY IDENTIFIED ABOVE, REQUEST:

- Relocation of solid waste collection services (regular, recycle, and bulk) from the alley adjacent to our properties to curbside, if applicable and eligible.
- Permission to install gates with locks at each end of the alley.

WE, AS THE PROPERTY OWNERS ADJACENT TO THE ALLEY IDENTIFIED ABOVE, UNDERSTAND AND AGREE WITH THE FOLLOWING STATEMENTS:

- If this request <u>is</u> approved for gates, all solid waste collection (including trash, recycle, and bulk trash collection) will be removed from the alley and permanently relocated to curbside. Collection containers will be provided to each resident by the Public Works Department. Once the solid waste collection services are moved from the alley to curbside, it will not be possible to move the collection services back into the alley.
- If this request **is not** approved for gates but the majority of property owners remain in favor of solid waste relocation as demonstrated by this petition, the Public Works Department will continue to evaluate the alley to determine if solid waste services can be safely relocated to curbside. Public Works will notify residents if the alley is approved for relocation.
- All property owners and residents adjacent to the alley will be provided with the combination to the lock on the alley gates. The combination must not be changed.
- All public utilities will be provided 24-hour access. Access must be provided to utility companies and emergency response vehicles and no structures or improvements are allowed that impede access except for the view gates at the ends of the alley.
- Alley maintenance is the sole responsibility of the adjacent residents to the alley. Per Section 27-16
  of the Phoenix City Code, abutting property owners will continue to be responsible for the maintenance
  of alleys adjacent to their property.
