Pursuant to Ordinance G-7156, Sec. 10-197(A)(8)- SHORT-TERM RENTAL PERMIT APPLICATIONS; CONTENT, a signed agreement must be submitted with each short-term rental permit application.

Pursuant to Ordinance G-7156, Sec. 10-200- CRIMINAL BACKGROUND VERIFICATION, the owner or owner's designee must submit a notarized attestation that **both the owner and owner's designee** are not registered sex offenders or have not been convicted of any felony act that resulted in death or serious physical injury, or any felony use of a deadly weapon during the 5 years before the permit application date.
