and shall not be affected in any manner by any sale of the Property by the Lienholder by foreclosure or power of sale.

D. In order to induce the City to purchase the Conservation Easement, the Lienholder has agreed to provide this Agreement. This Agreement is not intended to, nor shall it be constructed as affecting the priority of the Lienholder Interest.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual recitals, the City and the Lienholder hereby agree as follows:

- 1. <u>Consent</u>. The Lienholder hereby consents to the content, effect, execution and recording of the Conservation Easement and agrees that the Conservation Easement shall run with the Property and shall not be affected in any manner by any sale of the Property pursuant to the Lienholder Security Document, whether by foreclosure or power of sale.
- 2. <u>Benefit and Binding Effect</u>. This Agreement shall inure to the benefit of, and be binding upon, the parties, their respective representatives, successors and assigns.
- 3. <u>Attorneys' Fees</u>. In the event of litigation with respect to this Agreement, the prevailing party, as determined by the court, shall be entitled to recover its costs, expenses and fees, including attorneys' fees, as determined by the court.
- 4. <u>Governing Law</u>. This Agreement, its construction, validity and effect, shall be governed and construed by and in accordance with the laws of the State of Arizona.
