**UPDATE: March 5, 2026**

Since the date of this homicide, multiple investigative techniques were used by investigators leading them to multiple suspects. The first being 18-year-old Aarion January, who was arrested on February 15, 2026. After being interviewed, January was booked into jail on multiple charges related to this investigation to include murder.

The case continued, ultimately leading to the arrest of five additional suspects on March 4, 2026. These arrests took place during multiple search warrants served throughout the Phoenix metro area. Included in the arrests were two juvenile (teen) males, and three adults, identified as 25-year-old Junior Raybourn, 44-year-old Nicholas Estrada and 19-year-old William Salas-Mares. Each person arrested on March 4<sup>th</sup> was booked on multiple charges related to this investigation to include murder.

This remains an active investigation.

## Homicide Investigation

On February 8, 2026, at around 4:10 p.m., officers responded to the area of 33<sup>rd</sup> Avenue and Grand Avenue regarding a shots fired call. When officers arrived, they found an adult male, identified as 19-year-old Jabes Gurrola, with at least one gunshot wound. Gurrola did not survive his injuries was pronounced deceased on scene.

Phoenix Police Homicide Detectives responded to assume the investigation. Additional details related to this incident remain part of the ongoing investigation. Anyone with information is asked to contact the Phoenix Police Department or to call Silent Witness at 480(WITNESS) or 480(TESTIGO) and provide an anonymous tip. Rewards will be paid for information leading to an arrest in this case.
