The Compliance Academy is a free, voluntary program designed for the staff of Phoenix's Class A, B and C Permitted Industrial Users. Contractors and government employees may attend based on space availability. No one will be admitted to a class without receiving prior confirmation of enrollment. Confirmation of enrollment is usually completed within one week of the online enrollment request and will include log-in information for WebEx for those attending virtually.


