

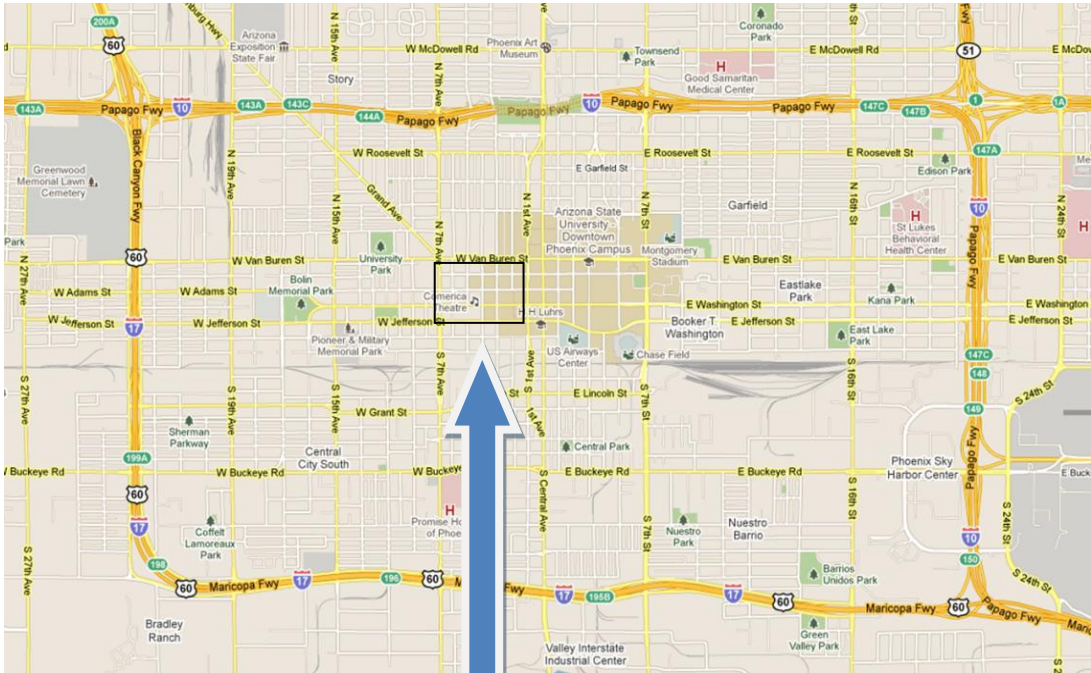

## Juror Parking Directions

### From the Northwest Valley via I-17 South

I-17 to I-10 East (exit 200A)

Exit at 7<sup>th</sup> Avenue (exit 144A) and turn right

Travel 1 mile to Jefferson Street and turn left

Move to the left lane

Turn left into City Public Parking Garage between 4<sup>th</sup> and 3<sup>rd</sup> Avenues

### From the Northeast Valley via SR51 South

SR51 to I-10 West

Exit at 7<sup>th</sup> Avenue (exit 144A) and turn left

Travel 1 mile to Jefferson Street and turn left

Move to the left lane

Turn left into City Public Parking Garage between 4<sup>th</sup> and 3<sup>rd</sup> Avenues

### From the West Valley via I-10 East

Exit at 7<sup>th</sup> Avenue (exit 144A) and turn right

Travel 1 mile to Jefferson Street and turn left

Move to the left lane

Turn left into City Public Parking Garage between 4<sup>th</sup> and 3<sup>rd</sup> Avenues

### From the Southeast Valley via I-10 West

Exit at 7<sup>th</sup> Avenue (exit 144) and turn left

Travel 1 mile to Jefferson Street and turn left

Move to the left lane

Turn left into City Public Parking Garage between 4<sup>th</sup> and 3<sup>rd</sup> Avenues

Note: The parking garage has a second entrance on 4<sup>th</sup> Avenue between Jefferson and Washington

## ADDITIONAL INSTRUCTIONS FOR HIGH PROFILE VEHICLES



For vehicles in excess of 6' 11" in height:

- Contact ACE Parking at 602 495-6777 at least one day before your service date for instructions to the high profile parking area in the garage at 305 West Washington Street.
- Once parked, take your jury service summons to the Parking Office on the Washington Street side of the garage. The Parking Office staff will take down your name/summons/plate information for that date and will invoice the court for your parking fee.
- If you do not have your jury duty summons you will need to obtain a parking pass form from the Jury Assembly Center in the courthouse first, and then return to the Parking Office.
- If you are selected to serve on a jury panel for additional days the jury center staff will provide a form for you to take to the Parking Office staff on the subsequent days.
- Please remember to advise the jury center staff that you have a high profile vehicle when checking in.
