

#### City of Phoenix Aviation Department Recognized for Its Commitment to Clean



The City of Phoenix Aviation Department is pleased to announce that it has been recognized in the GBAC STAR<sup>TM</sup> Facility Accreditation Program. Phoenix Sky Harbor, Phoenix Deer Valley and Phoenix Goodyear airports have all received this accreditation.

The Global Biorisk Advisory Council's GBAC STAR<sup>TM</sup> facility accreditation program is an outbreak prevention, response and recovery accreditation for facilities. It represents a high level of achievement within the cleaning industry, including 20 components that a facility must meet in order to achieve this accreditation. Facilities must also demonstrate that they have established and maintained a cleaning and disinfecting program to minimize risks of infectious diseases; have employed the proper protocols to clean and disinfect facilities; and have staff who are trained for outbreak and infectious disease preparation and response.

"Meeting the highest industry standards is a commitment that Phoenix's airports consistently work to achieve," said Vice Mayor Thelda Williams, chair of the Transportation, Infrastructure and Innovation Subcommittee. "Earning the GBAC STAR<sup>TM</sup> accreditation is the gold standard in a performance-based program and it demonstrates our commitment to safety and preparedness as we build confidence with our passengers, customers and employees in our facilities and procedures."



Throughout the COVID-19 pandemic, Phoenix Sky Harbor, Phoenix Deer Valley, and Phoenix Goodyear airports have employed a number of initiatives to ensure a safe, welcoming and healthy environment for those coming through the airports. This includes a robust cleaning program, the installation of plexiglass and UV-C LED sanitizing lights on escalator handrails and more.

## Metro Phoenix Transit Workers to Get COVID-19 Vaccines


The Valley's essential transit workers are now prioritized to receive the COVID-19 vaccine.

The Maricopa County Department of Public Health (MCDPH) will give the single-dose Johnson & Johnson vaccine during an event that occurs March 12-14. There are approximately 4,000 frontline transit workers who serve metro Phoenix communities.

The event is open only to public transit personnel including bus, light rail and paratransit workers and

is being shared with another sector of essential workers, United States Postal Service employees. Special thanks to MCDPH and the other event hosts—Phoenix

Union High School District and Albertson's/Safeway—for their commitment to frontline essential workers and protecting our community.



About a year ago, Valley Metro and the city of Phoenix began implementing more stringent cleaning protocols and safety measures to combat the spread of COVID-19 and protect frontline staff and passengers. Enhanced cleaning and boarding limitations were put in place, face coverings were mandated, and temporary barriers were installed in the driver area to create a safe distance between operators and passengers. Permanent barriers are being installed on the entire bus fleet now. ## FREE TAX PREPARATION



The City of Phoenix Volunteer Income Tax Assistance (VITA) Program has three alternatives for filing taxes for those meeting eligibility requirements. Residents can book a phone appointment with VITA, and a certified IRS tax volunteer will assist in preparing and e-filing taxes! To learn more visit Free Tax Prep.

- A phone call to confirm eligibility.
- Drop off of tax documents.
- Return and review: all taxpayers must be present to sign.

#### NORTHWEST EXTENSION PHASE II CONSTRUCTION UPDATE Week of March 12



The Northwest Extension Phase II (NWEII) project will extend light rail west on Dunlap Avenue from 19th Avenue, then north on 25th Avenue and across I-17 on Mountain View Road with a terminus on the west side of the freeway near Metrocenter Mall. Northwest Extension Phase II light rail project construction is underway by the project contractor, Kiewit-McCarthy, A Joint Venture (KMJV) and third-party utility companies, such as Salt River Project (SRP).

#### **Dunlap Avenue**

- Dunlap Avenue between 19th and 25th avenues: KMJV and SRP are performing underground utility relocation and roadway construction on Dunlap Avenue between 19th and 25th avenues during day and nighttime hours. Traffic lanes will be located on the south side of Dunlap Avenue and restricted to one west- and one eastbound lane. Traffic restrictions will be in place 24/7 through 5 a.m. Monday, May 31, 2021. Click <a href="here">here</a> for construction notice.
- Dunlap Avenue: 24th Avenue closure: KMJV is performing underground utility relocation and roadway construction on 24th Avenue, just north of Dunlap Avenue. This work will require a closure at the location. In addition, left turns will not be available for eastbound traffic at Dunlap and 24th avenues. Traffic restrictions will be in place 24/7 through 7 a.m. Monday, April 19, 2021. Click here for construction notice.
- Dunlap Avenue: 22nd Avenue closure: KMJV is performing underground utility relocation and roadway construction on 22nd Avenue, just north of Dunlap Avenue. This work will require a closure at the location. In addition, left turns will not be available for eastbound traffic at Dunlap and 22nd avenues. Traffic restrictions will be in place 24/7 through 5 p.m. Monday, March 15, 2021. Click here for construction notice.

#### 25th Avenue

- 25th Avenue between Dunlap Avenue and Mountain View Road: KMJV is reconstructing the Arizona Canal bridge on 25th Avenue between Dunlap Avenue and Mountain View Road during day and nighttime hours. Traffic lanes will be located on the west side of 25th Avenue and restricted to one southbound lane; northbound traffic lane is closed between 24th Avenue and north of the Arizona Canal bridge. Traffic restrictions will be in place 24/7 through 7 a.m. Monday, March 29, 2021. Click here for construction notice.
- Rose Mofford Sports Complex and Dog Park: KMJV is replacing drainage infrastructure in and
  adjacent to Rose Mofford Sports Complex and Dog Park. The work will involve removing fencing
  on the southwest corner of the dog park. Temporary fencing will be placed, allowing continued use
  of the park during construction. In addition, available parking areas will change throughout the
  process. The Rose Mofford Sports Complex and Dog Park will remain open during this work. The
  work will be completed in late spring 2021. Click <a href="here">here</a> for construction notice.

# I-17 AND HAPPY VALLEY ROAD RAMP CLOSURES AND RESTRICTIONS PLANNED FOR MARCH 13

The Arizona Department of Transportation advises drivers to plan ahead for restrictions at the Interstate 17, Happy Valley Road interchange on Saturday, March 13, while crews make signal timing changes.

Drivers should slow down in the work zone and use caution while the following restrictions are in place:

#### I-17 at Happy Valley Road Ramp Closures

- The northbound I-17 off-ramp will be closed from 7 a.m. to 5 p.m. Saturday, March 13.
  - Detour: Drivers may exit I-17 at Pinnacle Peak Road and use 19th or 43rd avenues to Happy Valley Road.
- The southbound I-17 off-ramp will be closed from 7 a.m. to 5 p.m. Saturday, March 13.
  - Detour: Drivers may exit I-17 at Pinnacle Peak Road and use 19th or 43rd avenues to Happy Valley Road.
- The northbound frontage road will be closed at Charlotte Drive from 7 a.m. to 5 p.m. Saturday, March 13.
  - o **Detour:** Drivers may use 23rd Avenue to access Happy Valley Road. The frontage road north of Charlotte Drive will be open to local traffic only.

#### Happy Valley Road at Interstate 17

East- and westbound Happy Valley Road will be restricted to two lanes between 23rd and 29th avenues from 7 a.m. to 5 p.m. Saturday, March 13.

## **CITY MANAGER'S REPORT:**

Public Transit and Valley Metro staff are coordinating a vaccination event for transit workers from March 12-14 at Cesar Chavez High School. Public Transit staff are working with Maricopa County since the determination that transit personnel were eligible essential workers. Detailed information regarding the vaccination event was shared on March 5 with the region's transit providers including an email template, posters with event details, an appointment registration website, and a QR code that can be easily scanned with smart phones. The registration website is active and transit personnel have been encouraged to sign up for appointments. The information has also been shared with transit union leadership.

#### **Economic Development & Education**

Arts and Culture staff are sponsoring an ongoing series of free, online professional development workshops to assist artists and arts organizations in developing stronger business practices. Arts attorney Sarah Conley Odenkirk returned on March. 4 to address legal and business issues for artists on contracts and negotiations. The next set of workshops include artist Bill Dambrova. On March 11, he will present pertinent information for artists interested in learning the use of software needed to develop digital documents, models and plans for public art projects. On March 17, Bob Swaney and Catherine Heitz New will finish the Successful Arts Fundraising in 2021 series for arts organizations. This last 90-minute webinar will focus on core fundraising practices adapted for the recovery environment. Information can be found at phoenix.gov/arts/workshops.

The Convention Center had two notable bookings, the American Society of Heating, Refrigerating and Air Conditioning Engineers (ASHRAE) 2025 Conference and the National Institute on Legal Issues of Educating Individuals with Disabilities. The ASHRAE is scheduled for June 2025 and estimates having 1,800 delegates equating to 4,490 total room nights. The National Institute on Legal Issues of Educating with Disabilities is scheduled for April 2025 with 2,000 estimated attendees and 4,611 total room nights.

Spirit Electronics, a value-added electronics distributor, was recently awarded the U.S. Historically Underutilized Business Zone (HUBZone) certification for small businesses. This federal program fuels small business growth with a goal of awarding at least three percent of federal contract dollars to HUBZone-certified companies each year. Community and Economic Development staff collaborated with the U.S. Small Business Administration, Arizona Procurement Technical Assistance Center, and the Maricopa Small Business Development Center to assist with the company's HUBZone certification. In addition, Spirit Electronics is certified as a Woman-owned and Veteran-owned business. These federal certifications are highly regarded in the Aerospace and Defense Industry where the company competes. Community and Economic Development staff is currently working with Spirit Electronics to identify relevant workforce development and training programs.

Community and Economic Development and Neighborhood Services staff have partnered to issue a Request for Interest (RFI) for a Neighborhood Services owned site, comprised of 12.1 acres of vacant land located at the southwest corner of 24th Street and Broadway Road. The goal of the RFI is to collect information from developers on creative project ideas that are market viable and of benefit to the surrounding community and City. The RFI will close on April 15, and an informational webinar will be hosted on March 18 at 9:00 a.m. The RFI will be advertised in the Arizona Builder's Exchange, NAIOP (the Commercial Real Estate Development Association) and the national Urban Land Institute. The RFI notice was also sent to all interested parties who have signed up to receive solicitation email notifications from Community and Economic Development. Between Feb 24 – March 2, Aviation staff distributed 7,370 FEMA masks to the traveling public.

Aviation staff will be contacting and following up with community partners to promote virtual aviation presentations and airport tours to Phoenix 99s, Arizona State University Summer Transportation Institute, South Mountain High School Aerospace Academy, Foundation for Blind Children and Civil Air Patrol.

Aviation staff is working with Kiewit Building Group INC, Aviation Operations and Aviation Design & Construction Services on the upcoming Terminal 2 mural relocation to the Rental Car Center. A field walk was completed on March 3 to determine the logistics behind the relocation of three large segments

of the mural to Level 3 of the garage. The mural will be installed on Level 3 near the base of the escalator by the Hertz Corporation. Staff will continue coordination efforts with the rental car stakeholders and contractor staff.

Aviation staff continues the final work for the PHX Sky Train in the 24th Street Station including signage installation, replacement of ceiling panels in the levels 1 and 2 lobbies and terrazzo flooring finishing work. Construction of the parking lot south of the 24th Street Station continues with rough grading, over excavation for wall footings and installation of storm drain. Construction of walls footings will begin in early March.

Communications and PHXTV staff celebrated International Women's Month by debuting 20 vignettes spotlighting women in the arts, education, politics and more. PHXTV and Communications staff are producing videos for the Outstanding Young Man & Young Woman of the Year as well as producing a series of Public Service Announcements for Kindergarten preparedness.

#### **Public Safety**

The next Police Recruit written exam is scheduled for March 13 at the Police Regional Academy. To date, 45 applicants have been invited to take the exam. The next Police Recruit written exam is scheduled for March 27. A job announcement is now open for applicants to register for the Police Recruit written exam for April 10.

#### Neighborhoods and Livability

On March 4, Neighborhood Services staff hosted the 2021- 2022 Annual Action Plan Public Hearing. In total, 35 residents attended the public hearing. During the meeting, Neighborhood Services staff provided an overview of the U.S. Department of Housing and Urban Development required Consolidated and Annual Action Plans and reviewed the results of the Annual Action Plan survey. The intent of the 13-question survey was to allow residents and stakeholders the opportunity to identify priority areas within each of the six overarching city goals within the consolidated plan. The survey was open from Feb.18- 24 and over 200 responses were received.

During the week of March 1, Parks and Recreation staff continued construction on the new Cesar Chavez Community Center. This week, block work, electrical panel energization, pulling wire, light pole installation and electrical inspections were completed. The new community center is slated to open in Fall 2021.

On March 5, a ribbon cutting was held at Deem Hills Park to celebrate the opening of Phase III. Some of the new amenities in this phase included two pickleball courts, a tennis court, sand volleyball court and a 0.7-mile nature trail. The event was small and participants wore masks and physically distanced in adherence to the current COVID-19 pandemic protocols.

#### **Social Services Delivery**

During the week of March 1, Housing staff in partnership with St. Mary's Food Bank distributed 465 lunches and 455 snacks to youth in the Edison Eastlake Community via the Kids Café program.

On March 2, University of Arizona Mobile Health Clinic provided 70 vaccines to senior/disabled residents living at Fillmore Gardens. Residents at Filmore Gardens will have their second dose scheduled on March 30. Many residents at this site do not have transportation to take them to the larger events.

On March 11, Housing staff in partnership with the University of Arizona Mobile Health Clinic will administer COVID-19 vaccines on-site at Pine Towers senior housing.

On March 2, Housing staff hosted a free community spay and neuter clinic at Aeroterra Community Center. Free sterilization and vaccine services were provided by Dr. Kelly's Mobile Unit and Fix, Adopt, Save. In total, 27 families and 42 companion animals were assisted with the free services.

On March 3, Housing staff and Gorman & Company hosted a virtual Housing Design community meeting for the Harmony at the Park Choice Neighborhoods housing development. The lead architect from Gorman & Company presented the final renderings and plans for Harmony at the Park. Residents were encouraged to submit feedback and questions to the architect. The presentation was recorded and will be shared with other residents and community members to view and complete follow-up surveys. In total, 21 people participated in the meeting including six residents and two community members.

During the week of March 1, Human Services staff conducted 2,102 wellness checks and delivered 2,810 meals for senior center members.

On March 1, the IRS reported the City of Phoenix's Volunteer Income Tax Assistance program electronically filed 107 tax returns for a total refund amount of \$207,023. Additionally, 50 "Do It Yourself" tax returns were also filed and a total of 34 families have been assisted during the week of March 1.

Humans Services staff recruitment for the Head Start Birth to Five program begins March 8 for the next school year. Staff will conduct approximately 4,000 intakes between March and July to fill the 3,451 available slots.

Last week, in partnership with St. Mary's Food Bank Alliance, Library staff served 701 meals to children and teens, ages 18 and under. The Kid's Café program is the result of a grant from the U.S. Department of Agriculture administered by the Arizona Department of Education. Meals are being provided Monday through Saturday during curbside pickup hours at select library branches.

To date, Library staff has provided curbside pickup services to more than 253,000 customers with approximately 2,352,000 physical library materials circulated by library cardholders.

Water Services and Library staff are collaborating to host two virtual water conservation workshops. Staff will host the first workshop, "Find and Fix Leaks" on March 18. On April 8, staff will host the "Water 101" workshop. Over 50 people are registered for the March workshop.

#### Infrastructure

Public Transit staff assisted in creating informational rider content for the Phoenix bus Route 7 detour due to the fire and bridge closure on Feb. 28. Public Transit and Valley Metro staff have collaborated to create laminated signs and assist Communications staff on social media in getting the word out about the detour and how the event affected other City services.

A Public Transit contract amendment to the Senior Center Shuttle Program, one of five Alternative Transportation Programs, was finalized on Feb. 25. The amendment allows a temporary service provision of transportation for senior center members to COVID-19 vaccination appointments in lieu of transportation to/from senior centers. The Senior Center Shuttle program has not been used since mid-March 2020 due to senior center closures because of the COVID-19 pandemic. During the week of March 1, Human Services staff will notify senior center members of the available transportation. Transportation

providers have been notified of the temporary service and are prepared to schedule service when requested by program members.

Public Transit and Complete Coach Works staff have completed barrier installations on 132 buses. Installations have been backlogged due to part shortages caused by East Coast storms and awaiting a stanchion for New Flyer Excelsior buses.

Water Services' Water Production Well 301 was drilled in 2011 to supplement water supplies from the Northwest Water Aquifer during times of high demand and drought. The well has been under construction since March 2020 and is anticipated to be substantially completed by April 2021. This well will use an arsenic treatment system for treatment.


Water Services' existing pump station located along Baseline and 42nd Place is at the end of its useful life. The design by Wilson Engineers includes construction of a new Booster Pump Station (BPS) with seven pumps and a Pressure Reducing Valve (PRV) station with four PRVs to improve pumping capacity and provide improved expansion opportunities, along with a new by-pass system to provide additional system redundancy and a 48-hour back-up power system. The new BPS and PRV station will be built in front of Fire Station No. 32.
