
JUNE 19 STATEMENT FROM COUNCILWOMAN WILLIAMS ON 2020 CENSUS

Have you been counted in the 2020 Census?

As of June 18, 59.4 percent of households in Phoenix responded to the census, statewide 58.1 percent, and nationally 61.6 percent of households have responded.

Currently, nearly four out of 10 households have yet to respond to the 2020 Census, which is why I along with the Census Bureau urge every household to complete it as soon as possible online, by phone or by mail. Households that do not respond to the invitation will be visited by a census taker. Your response shapes decisions about how public funds are spent for schools, fire and emergency services, and health care for your community.

COUNCILWOMAN WILLIAMS IN THE NEWS: PANDEMIC SHOWS IMPORTANCE OF FILLING OUT CENSUS

In today's Arizona Republic, my guest column focused on the importance of the Census:

The COVID-19 crisis has undoubtedly turned a public eye on the importance of resources like hospitals and emergency services.

In the coming months, the pandemic will continue to demonstrate how critical it is for the continuation of programs and services that matter in our communities, like hot lunches for schoolchildren and medical resources for older adults. Funding for these programs and services is impacted by census data.

An accurate population count in our city ultimately helps with all types of funding, including dollars allocated for emergencies like the one we are in now. And so now more than ever, we need to ensure every person, in every household, in all of our Arizona communities are counted in the 2020 Census.

The city of Phoenix has gone to great lengths to achieve the most accurate count, and over the last three months, the city's self-response rate to the 2020 Census is 60%. Yet, a complete count is far from over.

There are neighborhoods surfacing as potentially undercounted areas and trending far below the city's self-response average. There is potential that the people who live in historically undercounted areas were disproportionately impacted by the disruptions created by the novel coronavirus and find themselves dealing with more pressing issues delaying their response. We must take extra steps to ensure these neighborhoods are counted, so they can receive the funding they need!

To get ahead of this trend, Phoenix took a proactive extra step on May 11 when it sent a team of trained canvassers to areas with low self-response rates, encouraging households to fill out their form. The canvassers were identifiable representatives of the City of Phoenix 2020 Census and were equipped with educational door hangers which have been minimally handled before being dropped off.

The canvassers will continue circulating through undercounted communities through mid-August and will adhere to guidelines established by the Centers for Disease Control and Prevention – wearing masks, gloves and practicing contactless strategies – as they work to educate the undercounted.

Executing a personalized outreach effort like this one is imperative, as people who are dealing with the impacts of COVID-19, may find that filling out their census form has become less of a priority under the circumstances.

While the deadline to fill out the census form has been extended to October, this may also cause people to delay or forget about completing their questionnaire. For these reasons, the canvassing outreach is timely and critical. After all, we only have one chance every ten years to obtain an accurate count of the entire population. Together, we can seize this chance!



SMALL BUSINESSES RESOURCES

Funding Still Available in Phoenix Small Business Resiliency Grants Program for COVID-19 Health Emergency Impacts

Grant award notifications have been delivered to 85 businesses in the first batch of Phoenix Microbusiness Resiliency Grants. These grants help offset losses related to the COVID-19 health emergency. The total grants value topped \$300,000. It's part of the Phoenix Small Business Resiliency Grants program offered by the city of Phoenix and the Phoenix IDA. Below are the three grants still taking applications:



- The Phoenix IDA Small Business Relief Grant offers as much as \$10,000 for qualifying small businesses located in, and adjoining, low-income neighborhoods in the city. Businesses must have had fewer than 25 employees on March 1, 2020, and calendar year 2019 gross sales of under \$3 million. [Small Business Relief Grants](#)
- The Phoenix Microbusiness Resiliency Grant is open to businesses located anywhere in the city with five or fewer employees and under \$1 million in 2019 gross sales. Microbusinesses can have brick and mortar addresses, be a home-based business or a mobile business. [Phoenix Micro Business Resiliency Grant](#)
- Phoenix Restaurant Restart Resiliency Grants applications are open. The grant helps cover the costs of reopening a restaurant by September 1, 2020. Restaurants with fixed Phoenix locations and food trucks headquartered in Phoenix are eligible to apply for the grant. [Phoenix Restaurant Restart Resiliency Grant](#)

Altogether, the city allocated enough money to help more than 2,000 of these businesses with grants, which will not have to be repaid. The Arizona Community Foundation administers all grants and information and applications are available at AzFoundation.org/PHXGrants.

PHOENIX PUBLIC TRANSIT

Phoenix Public Transit Requires Passengers to Wear Face Covering While Riding Starting July 1

Beginning Wednesday, July 1, passengers are required to wear face coverings while riding transit in Phoenix to help prevent the spread of COVID-19. The use of face coverings is also strongly encouraged while waiting at bus stops or other transit areas where social distancing may not be possible. Look for updates regarding regional discussions on requiring face coverings on transit scheduled with Valley Metro.



Beginning June 22, and as supplies allow, Phoenix Public Transit will provide face coverings for riders at the following transit centers: Central Station on Central Avenue and Van Buren Street, Ed Pastor on Central Avenue and Broadway Road, Metrocenter at the Metrocenter Mall, and Sunnyslope on 3rd Street and Dunlap Avenue.

Face coverings will not be distributed on public transit vehicles, although distribution may occur in the coming weeks at additional city facilities as supplies allow. Further information on Phoenix social media channels and website will provide details on when and where additional mask distribution will take place.

Riders are urged to plan ahead and bring their own face covering, which may include masks, face shields, homemade cloth coverings or other cloth positioned to cover the mouth and nose. Detailed information on the use of face coverings, including how to make your own at home, can be found at the [Centers for Disease Control and Prevention \(CDC\)](#) website.

For health and safety reasons, there are exemptions to the face covering requirement:

- Children ages 2 years and younger. Children in this age group should not wear masks/face coverings.
- Anyone with a disability that makes it difficult for them to wear or remove a face covering.
- Anyone who has been advised by a medical professional to not wear a face covering because of personal health issues.
- Anyone who has trouble breathing or is unable to remove the face covering without help.

In many cases, it is not apparent who is exempted, so we encourage riders not to get involved with other passengers who are not wearing a face covering. Public transit personnel will be instructed not to prevent riders who do not have a face covering from boarding or riding. Additionally, law enforcement will not be involved in enforcing the wearing of face coverings on public transit.

PHOENIX WATER SERVICES

Phoenix Water Grows Trees to Revitalize Tres Rios Wetlands and Provide Trees to Surrounding Parks and Preserves



The lush and scenic Tres Rios Wetlands are full of cottonwood groves, willows, mesquites, palo verde and other desert trees around the reed-lined ponds. Among these native trees lives the highly invasive salt cedar. These problematic trees diminish the health of surrounding trees by taking away water and nutrients. “A fully-grown salt cedar can drink up to 200 gallons of water a day,” said Lisa Bird, Operations & Maintenance Supervisor at the Tres Rios Wetlands.

As Phoenix Water staff remove the overpowering salt cedar, they replace it with native plants to prevent the salt cedar from growing back. The team at the 91st Avenue Wastewater Treatment Plant grow trees from native seed pods rather than purchasing more trees.

The project started over two years ago by building a structure with supplies already on hand and a goal to grow more desert trees.

Throughout the year, staff harvest seed pods from native desert trees at the wetlands. They strategically plant seeds in stages year-round to always have trees readily available. These seeds are planted in tall pots or PVC pipe and grow in a shaded structure until they are ready for planting. The tall pot allows young plants to develop a tap root as long as 30 inches. A healthy taproot allows the plant to reach water deep in the soil.

Last year 250 trees were grown and almost all of them have successfully matured in the ground. The shade structure now has the capacity to produce 1,000 trees. Phoenix Water donates some of the trees to the Parks and Recreation Department. Since March of 2019, 272 trees have been donated to the Rio Salado Habitat Restoration area, 15 to North Mountain Park, North Mountain Visitor Center and Deem Hills Preserve areas and 8 to the Sonoran Preserve.

PHOENIX FIREWORKS



The Phoenix Fire Code prohibits the use and sale of consumer fireworks in the City of Phoenix. However, Arizona Revised Statute (A.R.S. or state law) prohibits the City of Phoenix from enforcing the ordinance relating to permissible consumer fireworks during the following dates:

- A.R.S. allows consumer fireworks **sales** between:
 - April 25 through May 6
 - May 20 through July 6
 - December 10 through January 3
- A.R.S. allows consumer fireworks **use** between:
 - May 4 through May 6
 - June 24 through July 6
 - December 24 through January 3

A.R.S. allows Fire Prevention to permit and inspect sales locations based on the quantities of consumer fireworks for sale.

"Permissible consumer fireworks" allowed by A.R.S.

Ground and handheld sparkling devices, cylindrical fountains, cone fountains, illuminating torches, wheels, ground spinners, flutter sparklers, toy smoke devices, wire sparklers or dipped sticks, multiple tube ground and handheld sparkling devices, cylindrical fountains, cone fountains and illuminating torches.

A.R.S. **prohibits** any consumer firework that is intended to rise into the air and explode or to detonate in the air or to fly above the ground, including firework items defined and known as firecrackers, bottle rockets, sky rockets, missile-type rockets, helicopters, aerial spinners, torpedoes, roman candles, mine devices, shell devices and aerial shell kits or reloadable tubes.

Fireworks retail sales inspections

A.R.S. allows Fire Prevention to permit and inspect sales locations based on the quantities of consumer fireworks for sale. Fire Prevention inspects the various tents around the City of Phoenix that sell consumer fireworks to ensure the tents are compliant with the fire code, and the maximum allowable fireworks quantities are not exceeded. Each consumer fireworks sales location is required to have a fire inspection if they exceed the permissible quantities of consumer fireworks.

WEATHER ALERTS

Local news outlets and the National Weather Service @NWSPhoenix will post weather alerts. Follow them on social media for updates.



FLASH FLOODS

Pay attention to signs that warn of flood areas. **Never** cross a flooded wash or road. Just six inches of water can wash away most vehicles.



FLOOD BARRIERS

Instead of sand bags, residents should consider innovative, water barrier options like self-activating flood barriers. These products are reusable and can be found online or at local hardware stores.



STORM CLEANUP

If your yard is damaged during a storm, take your branches and debris to a city Transfer Station to be composted. Residents can drop off up to one ton of waste for free each month. Phoenix.gov/TransferStations



DRIVING TIPS

When driving in a severe storm, pull over if possible and wait it out. If it's a dust storm, park off the road shoulder and turn your vehicle **lights off**.



PREPARE A GO KIT

Prepare a portable pack that allows you to be self-sufficient for 72 hours. Include food, water, cash, flashlight, batteries, first aid supplies, and medicine.

STREET TRANSPORTATION: HAWK LIGHT MODIFICATIONS


Signal Timing at HAWK Pedestrian Signals Modified to Improve Safety for Pedestrians and Bicyclists

To help increase safety as more people are walking and riding bicycles, the Street Transportation Department reprogrammed its HAWK pedestrian signals to minimize time people spend waiting to cross the street at its HAWK signals.



HAWKs are traffic signals that allow people to cross the road safely and operate in a YELLOW–RED–FLASHING RED sequence to alert drivers that there are people who need to cross the road. All HAWKs will be programmed to minimize wait delays by as much as 50 percent. Some HAWK signals had a 60- to 90-second delay between activations. The gap between activations at most HAWKs will now be only 30 to 40 seconds.

“With fewer cars on the roads, decreasing the wait time for people walking or riding bikes will discourage people from crossing the road without the signal,” said Councilwoman Thelda Williams, who chairs the Transportation, Infrastructure and Innovation Subcommittee. “The reprogramming of the HAWKs will be a permanent change to help improve safety for pedestrians and bicyclists.”



HAWKs that are programmed to coordinate with nearby traffic signals will continue to work in a coordinated fashion but wait times were also improved at these locations. The changes resulted from close collaboration between the Street Transportation Department’s Office of Pedestrian Safety, the Active Transportation Program and pedestrian and bicycle advocacy groups.

Unlike standard traffic signals, HAWKs only operate when a person pushes the crossing button. Vehicles are free to move when the signal is dark and no one is waiting to cross the road. Phoenix currently has 65 HAWK signals and they have all been updated in recent weeks.

OVERNIGHT RAMP CLOSURES, I-17 LANE RESTRICTIONS CONTINUE NEXT WEEK FOR INTERCHANGE PROJECTS AT HAPPY VALLEY AND PINNACLE PEAK ROADS

Drivers who use Interstate 17 and the interchanges at Happy Valley and Pinnacle Peak roads in north Phoenix should slow down in the construction zone and use caution while the following restrictions and closures are in place through June 27:

Interstate 17 at Happy Valley Road

- Northbound I-17 will have nightly lane restrictions from 9 p.m. to 5 a.m. beginning Monday, June 22 until the morning of Saturday, June 27.
 - Northbound I-17 will be restricted to one lane on Monday night and restricted to two lanes Tuesday through Friday nights.
- Southbound I-17 will have nightly lane restrictions from 9 p.m. to 5 a.m. beginning Monday, June 22 until the morning of Saturday, June 27.
 - Southbound I-17 will be restricted to two lanes on Monday night and restricted to one lane Tuesday through Friday nights.

Happy Valley Road at Interstate 17

- The southbound I-17 on-ramp at Happy Valley Road will be closed from 9 p.m. Thursday, June 25 until 5 a.m., Friday, June 26.
- Detour: Drivers can use southbound 43rd or 19th Avenue to Pinnacle Peak Road to access the southbound I-17 on-ramp.
- Traffic entering southbound I-17 at Happy Valley Road will be shifted to a temporary on-ramp just east of the existing on-ramp beginning at 5 a.m. Thursday, June 25 while the new southbound on-ramp is completed.

Pinnacle Peak Road at Interstate 17

- The north-and southbound I-17 off-ramps at Pinnacle Peak Road will be closed from 9 p.m. Tuesday, June 23 until 5 a.m., Thursday, June 25.
- Detours: Northbound traffic may exit at Deer Valley Road and use northbound 19th Avenue to access Pinnacle Peak Road. Southbound traffic may exit at Jomax Road and use 19th Avenue to access Pinnacle Peak Road.
- East-and westbound Pinnacle Peak Road will be closed between 29th and 23rd avenues from 9 p.m. Wednesday, June 24 until 5 a.m., Thursday, June 25.

Detour: Traffic west of I-17 may use 43rd Avenue to Happy Valley Road or 35th Avenue to Deer Valley Road for east/west travel. Traffic east of I-17 may use 19th Avenue to Happy Valley Road or Deer Valley Road for east/west travel. *Schedules are subject to change based on weather and other unforeseen factors. Cool Pavement Pilot Program

The City of Phoenix Street Transportation Department selected portions of eight neighborhoods and one city park to receive cool pavement treatment as part of a pilot project. Cool pavement is lighter in color than traditional asphalt or other seal coatings. Cool pavement reflects back the sunlight that hits it. Because the surface reflects rather than retains heat, cool pavement has the potential to offset rising nighttime temperatures in Phoenix.

The department is applying this cool pavement coating to extend the life of existing pavement and allow us to study the effectiveness and durability of the material. They have prepared the [Cool Pavement](#) webpage to help answer some of the most common questions people may have about cool pavement and the city's pilot project.

Neighborhood Notification: Bicycle Improvements on Stetson Hills Loop from Happy Valley Road (43rd Avenue) to Happy Valley Road (39th Avenue)

As part of the Street Transportation Department's core mission, we strive to improve the City's roadways to create a safe and efficient transportation network. Our ongoing pavement maintenance program provides opportunities to change the current traffic lane striping to improve safety for people who walk, drive, ride bicycles and use transit.

About the Project

Where: Stetson Hills Loop from Happy Valley Road (43rd Avenue) to Happy Valley Road (39th Avenue).

What: Where there is enough space on the roadway, buffered bicycle lanes, a parking lane and a two-way left turn lane will be added. The number of travel lanes will remain the same.

When: Pavement maintenance (new asphalt) is scheduled for late summer / early fall 2020 and traffic lane striping improvements will happen shortly after.

Why: Buffers add space between people driving and people walking or biking, increasing protection from vehicles, improving safety and adding comfort. Additionally, the slight narrowing of the lane widths to accommodate the buffers will help to guide cars and deter speeding.






WESD Offers New Phone-in Registration
