Continuity of Operations: Training and Exercise

On Wednesday October 13th, OHSEM will be hosting a 'Train the Trainer' event to instruct COOP Planners on how to conduct a basic Tabletop Exercise (TTX) with their respective departments. This event will help strengthen citywide efforts to maintain operational readiness in the wake of a continuity event – specifically a cyber-attack. Departmental COOP Planners will be provided guidance and training materials in a flexible format so that departments can strengthen their resilience and ultimately improve upon their plan.



Exercising your departments Continuity of Operations Plan (COOP) increases your department's ability to restore and maintain essential functions after a disaster incident and communicate with staff and stakeholders before, during and after an event.

By learning how to conduct exercises within each department, gaps should be identified that may exist between response actions and their written COOP plan. COOP Planners within each respective department will then take lessons learned during the TTX and use it for improvement planning to update their COOP plan.

Attendance for Primary COOP Planners is mandatory since all City of Phoenix Departments are to conduct at least one COOP exercise annually.

2021 Monsoon Season Recap

Although initial predictions for this year's monsoon season only anticipated a 33% chance of more than average rainfall, the records show that 2021 turned out to be one of the businest monsoon seasons on record!

The National Weather Service had the following breakdown of the 2021 monsoon season (all rainfall totals based on rain guages at the Phoenix Sky Harbor International Airport):

- From June 15th to June 30th, 0.17" of rain: **11th** wettest on record
- The month of July registered 1.73" of rain: **17**th wettest on record
- The month of August registered 1.54" of rain: 26th wettest on record
- From June 15th to September 1st, 3.87" of rain: **13th** wettest on record
- There were 23 days of measurable rain from June 15th to September 26th which is the **2**nd most on record (only one day short to tie the all time records of 24 days, set in 1896)



Although the rainfall was needed to offset some of the drought conditions in and around Phoenix, the frequency of the monsoon storms also presented own set of hazardous conditions, such thunderstorms, flashfloods, and severe winds, that threatened life and damaged property across the Valley. Whether it was rescuing people from submerged vehicles, directing traffic around downed power lines, or restoring flooded roads,

City of Phoenix employees worked through dangerous conditions to assist those in danger and ensured city services were provided around the clock. OHSEM would like to take this opportunity to **thank all first responders and city staff** who made sure people and property were kept save through the record rainfall.

As we close out this monsoon season, OHSEM will be working with City Departments that were involved in monsoon mitigation, response, and recovery activities to document lessons learned and all necessary metrics to compile an After Action Report (AAR). The AAR will help identify how resources were used and capture take aways and best practices that may have occured this season. This information will be used to prepare the city for possible winter storms and whatever the 2022 monsoon season may have in store.
