
# **PROJECT OVERVIEW**

In 2020, the City of Phoenix was awarded a \$1 million dollar Transit Oriented Development (TOD) Planning Grant from the Federal Transit Administration (FTA) to engage with the communities located along the Northwest Extension Phase II Light Rail extension and to develop a TOD community plan for the area to work towards implementing more sustainable and walkable communities.

### **NWEII AREA**

The I.6-mile Northwest Extension Phase II will provide an important connection from Valley Metro's light rail system at 19th and Dunlap Avenues to the former Metrocenter Mall area in Phoenix. The project also includes three new stations, including the system's first elevated station, and public art. The Northwest Extension Phase II TOD planning area is generally bounded by 19th Avenue on the east, 35th Avenue on the west, Peoria Avenue on the north, and Butler Road on the south.

### SUPPORTING SUSTAINABLE & WALKABLE COMMUNITIES

Since it's adoption in 2013, the City of Phoenix TOD Strategic Policy Framework has been utilized successfully to provide a holistic and multidisciplinary engagement, visioning, and implementation plan framework for several diverse transit-oriented communities in Phoenix. The framework consists of six (6) planning elements (Land Use, Housing, Economic Development, Mobility, Health, and Green Systems) to ensure a multidisciplinary process.

It is important to recognize that the six planning elements are intrinsically interconnected to one another, meaning changes in the defining factors of one element are likely to have impacts that affect the conditions of other elements. The framework, combined with active engagement of the community, works towards creating a plan that is responsive to the specific needs and desires of the community.
