BACKGROUND

Pursuant to Section 48-716, Arizona Revised Statutes, as amended, the District Treasurer of the Park Central Community Facilities District, (the "District") has caused to be prepared for the Board of Directors of the District (the "District Board") a proposed budget for the fiscal year 2023-24 (the "District Budget") and has caused the proposed District Budget to be submitted to the District Board for approval by adoption of a resolution. Pursuant to Section 3.11(b) of the District Development, Financing Participation, Waiver and Intergovernmental Agreement executed in connection with the formation and activities of the District, the District Treasurer has also caused to be prepared for, and submitted to, the District Board a proposed five-year financial plan for the District (the "Five-Year Forecast").

The next meeting of the District Board is scheduled for Wednesday, May 31, 2023, at 2:30 p.m., immediately preceding the regular meeting of the Phoenix City Council. At this meeting, the District Board will be asked to consider for adoption Resolution No. PC-16, the proposed District Budget and proposed Five-Year Forecast. This resolution will approve the proposed District Budget for fiscal year 2023-24 and the proposed Five-Year Forecast and call for a public hearing on such budget and forecast on June 14, 2023, for final adoption. Attached to Resolution No. PC-16 as Exhibit "A" is the proposed District Budget for fiscal year 2023-24 and as Exhibit "B" is the proposed Five-Year Forecast.
