City sets special election on employee retirement system

On Tuesday, Nov. 4, Phoenix voters will vote on Proposition 487, a proposed amendment to the City Charter related to the city's employee retirement system. This measure will appear on the ballot for the Nov. 4 General Election being conducted by Maricopa County.

City voters on the Permanent Early Voting List (PEVL) will automatically receive an early ballot by mail. Voters who are not on the PEVL can request an early ballot, no later than Friday, Oct. 24, by calling 602-506-1511 or online at recorder.maricopa.gov/EVRequest. Voters will begin receiving early ballots on Thursday, Oct. 9. **Voted early ballots must be received by**

7 p.m. on Election Day (Tuesday, Nov. 4).

For voting at the polls, polling places will be used instead of voting centers. On Election Day from 6 a.m. to 7 p.m., voters must cast their ballot only at the specific polling location designated for the precinct where they reside. The name and address of the polling place for each voter household will be on the Sample Ballot (provided by Maricopa County) and the Publicity Pamphlet (provided by the city) that will be mailed prior to the election. Holiday Trash and Recycling Collection

The city's Public Works Department will collect your trash and recycling on **Veterans Day, Tuesday, Nov. 11**. If your usual collection day is Tuesday, please make sure your containers are at the curb by 5:30 a.m. on Nov. 11.

To better serve you, always place your containers at least four feet apart and clear of obstructions, such as light poles, parked cars, and mail boxes.

Trash and recycling will NOT be collected on **Thanksgiving Day, Thursday, Nov. 27**. Instead, Thursday collection moves to Friday, Nov. 28; Friday's collection moves to Saturday, Nov. 29.

The North Gateway and 27th Avenue transfer stations are closed on holidays.

TO USE THIS SCHEDULE

- Locate your numbered area on the map.
- Find the area number on the schedule.
- Bulk trash must be placed out by 6 a.m. on the 'Collection Week Of' date.
- Placement is allowed only between your area's listed dates.
- If you have curbside collection of green containers, you should place your bulk trash curbside.
- If you have alley collection of large black containers, you should place your bulk trash in the alley.

Look at this map to see if your collection designation has changed.


ONE WEEK RULE

City ordinance allows only nine days prior to the schedule collection week to place bulk trash out for collection. It is a violation of city ordinance to place trash out before the listed "Placement Begins On" date.

BULK TRASH CREWS DO NOT PICK UP...

- More than 20 cubic yards per residence, or a pile the size of a SUV.
- Loose debris and litter. Please sweep or rake after collection if necessary.
- Loose grass, leaves, weeds, twigs and hedge clippings. These items must be bagged or boxed and securely tied to be collected.
- Household hazardous waste (HHW), such as antifreeze, pool chemicals, oil, batteries and paint.
- Community piles.
- Materials such as bricks, concrete, dirt, rocks, asphalt and roofing shingles/tiles.
- Construction materials in excess of 25 lbs. or over four feet long generated by a residence.
- Any construction material generated by a contractor.



- Metal or car parts in excess of 20 lbs. or over four feet long.
- Any type or size of tire.
- Glass such as windows, shower doors, patio doors, mirrors, fluorescent tubes, etc.
- Appliances that use refrigerants such as freezers, refrigerators, and air conditioners.

Green organics collection reminder

Have you signed up for the Green Organics Curbside Collection program yet? If you have, here is a reminder about what should and should not be placed in your Green Organics tan container:

SHOULD BE PLACED:

Grass clippings, tree branches, leaves, twigs, untreated wood (not bagged). The green organics waste that is collected is processed into mulch. This is not a composting program.


SHOULD NOT BE PLACED:

Palm fronds, oleanders, pyracantha,

creosote, treated wood, trash, food waste, pet waste and recyclable materials. These materials contaminate the green organics load and make them unusable for mulching and repurposing.

Eligibility to sign up for the Green Organics Curbside Collection program depends on where you live. To determine if your area is part of the first phase implementation, visit phoenix.gov/publicworks.

Make sure your containers are 4-feet apart

Please be sure to place your containers at the curb no later than 5:30 a.m. on the day they are to be picked up and allow 4 feet of space between each container. Containers also may be placed at the curb prior to your scheduled collection day. Make sure that trash is bagged and tied, and lids of containers are closed securely.

Office of Arts and Culture awards grants

The Phoenix Office of Arts and Culture will award a total of \$805,346 to 47 nonprofit arts and culture organizations that serve Phoenix residents through arts and culture activities.

Grant funds support the general operating costs of major, mid-size and small arts and culture organizations, specific arts projects related to festivals, as well as arts education activities. The funding, which was approved by the Mayor and City Council, remains the same as was made available in 2013.

Meanwhile, the Office of Arts and Culture's Public Art Program - in partnership with Friendly House and the Arizona State University School of Film, Dance and Theatre in the Herberger Institute for Design and the Arts - recently was notified that it will receive a \$100,000 National Endowment for the Arts Our Town grant.

Mark your calendar for Household Hazardous Waste events

Here's the schedule for the next Household Hazardous Waste (HHW) events in October and November:

- Friday and Saturday, Oct. 3 and 4, 7 a.m. to noon
North Phoenix Baptist Church 5757 N. Central Ave.
- Friday and Saturday, Nov. 7 and 8, 7 a.m. to noon
Paradise Valley Park 17642 N. 40th St.

HHW events are only for city of Phoenix residential solid waste customers. Proof of city of Phoenix solid waste service is required. Please bring your current city of Phoenix city services bill showing solid waste fees and a matching photo ID.

Non-hazardous materials brought to events will be sorted and disposed of as municipal solid waste. No commercial loads, large residential quantities, medical waste, explosives or radioactive waste will be accepted. A maximum of five over-the-road-tires per resident will be accepted; tractor or oversized tires will not be allowed.
