#### **Purpose:**

Established in July of 2005 to:

- Address problem liquor establishments (restaurants, convenience stores and bars).
- Reduce calls for service, acts of violence, traffic accidents, and complaints.

#### **Enforcement Direction:**

The Liquor Enforcement Detail initiates investigations based upon:

- Statistical Data
- Precinct Request
- Citizen Complaints
- Council Requests

The Liquor Enforcement Detail coordinates the Hot Spot Liquor Task Force, a multi-department, multi-agency coalition that works together to bring problem liquor businesses into compliance with the law.

### Liquor Enforcement Detail Duties include:

 Coordinating the Hot Spot Liquor Task Force

- Planning and conducting undercover investigations
- Testifying in court, City Council meetings, Zoning (Use Permits), Board of Adjustment, and Liquor Board hearings
- Reviewing liquor license applications, special event applications and temporary extension requests
- Proposing draft legislation

#### What can you do?

If you see a sign in your neighborhood that announces that a new liquor application has been applied for, ask questions about it.

You can call License Services at 602-262-4638, your precinct CAO (Community Action Officer), or the Liquor Enforcement Detail. Please let us know if you have an opinion or concern about a new application.



## **Components of an effective protest include:**

- Name and address of the establishment
- Name, address, phone number and signature of the protestor
- Reason for the protest
  - At a minimum, a protest should state that you do not believe that the public convenience and the best interest of the community will be substantially served if the license is issued.
  - More information can be obtained by calling License Services at 602-262-4638

### Important things to remember about protesting:

- Protestors must reside in, own or lease property within a 1mile radius of the proposed license.
- It is easier to deny a liquor license application than it is to revoke an existing license.
- Pick your battles. Some applicants want to help the area.
- Individuals or groups can protest.
- Write legibly.

You can report existing problem establishments to your precinct Liquor Liaisons, CAO or the Liquor Enforcement Detail.
