NEW CITY OF PHOENIX PROCUREMENT WEBSITE FORMAT**

The City implemented a new procurement website format on Monday, June 30th. The new format allows all procurements to be listed in one location with the ability to narrow searches by department.

Please go to the cities webpage at phoenix.gov, click on "Doing Business in Phoenix", next click on "Contracting with the City", next click on "View capital improvement projects" and lastly click on "Current Opportunities".

The "Current Opportunities" web page is intended to list only the *citywide capital improvement projects* procured by the Street Transportation Department under the authority of the City Engineer. However, at this time you may see a listing of all city procurements.

In order to assist interested firms during the procurement website transition, a listing of citywide capital improvement projects is included on page 3.

Construction of the procurement website should be "substantially complete" during the next week. When complete, firms will have the opportunity to view all city procurements through a central procurement tab or consulting and contracting services through the capital improvement projects tab.

GENERAL NOTICE

ARIZONA UNIFIED CERTIFICATION PROGRAM (UCP) FOR DISADVANTAGED BUSINESS ENTERPRISES (DBE)

The Arizona Unified Certification Program has been established to facilitate statewide Disadvantaged Business Enterprise (DBE) certification. The UCP eliminates the need for DBE applicant businesses to obtain certification from multiple agencies, and provides reciprocity within Arizona. The Arizona Department of Transportation, City of Phoenix and the City of Tucson are members of the Arizona UCP. The official UCP DBE database, located at "www.azdbe.org" includes DBE firms certified by these three agencies. **Companies who are meeting goals on FAA, FHWA and FTA federally funded contracts can only use the DBEs certified by the Arizona UCP.**

This website is user friendly and allows users to search by company name or owner's first or last name, and all firms with like names will appear. The website also allows searches by NAICS code and company description to help prime contractors identify DBEs certified in specific scopes of work.
