

Questions and Answers:

1. Is this going to be a new pipe or a rehab of an existing pipe?
 - a. This is a brand-new 66-inch pipeline.
2. On what side of the road is the pipeline being installed?
 - a. The pipeline is on different sides of the road depending on the location. Please contact our team if you have a question about which side of the road the pipeline will be installed in your area. The full design of the pipeline cannot be shared due to Homeland Security Critical Infrastructure Protection Laws.
3. Will 32nd Street remain open?
 - a. 32nd Street will remain open. In the active work zones, which are anticipated to be about 1,200 feet long (approximately ¼ mile) at a time. There will be at least one lane of traffic in each direction.
4. How long will there be restrictions at 32nd Street and Bell?
 - a. For the initial construction of the valve and connection to the existing water transmission system, the area will be restricted for three months (November 2020 – January 2021). In 2021, when the new pipeline is installed along Bell Road between 32nd St and 31st St, the area will be impacted again. 5. What timeframe will the bike path at Dreamy Draw be closed?
 - a. Approximately Spring 2021 through late 2022. Please sign up for email updates so you can stay informed on a weekly basis of the construction activities and schedules. Construction schedules provided are subject to change due to weather or other unforeseen conditions.
6. Will the bike lane on 32nd Street be restricted?
 - a. Active work zones will require bike lane closures or restrictions. Please sign up for email updates so you can stay informed on a weekly basis of any restrictions, construction activities and schedules.

7. Will the access road to SR 51 be closed at any time?
 - a. There will be restrictions on the Northern Avenue frontage however, access to SR 51 at 32nd Street and also at 26th Street will not be affected.

9. What will be the impact on 32nd Street businesses and how will they be reached out to?
 - a. Our team started visiting businesses, schools, and churches individually in September 2020, and personal outreach will continue throughout the project, as well as email updates, mailings, and door hangings.

11. Is this meeting being recorded?
 - a. Yes, the virtual public meeting was recorded and available on phoenix.gov/droughtpipeline
12. What will the traffic restrictions be on 32nd Street and for how long?
 - a. See #3
13. How will the pipe installation under SR 51 affect traffic?
 - a. We do not anticipate any impacts to SR 51 traffic during this operation. There will be restrictions along the Northern Avenue frontage road and construction restrictions on 32nd Street may impact traffic coming to & from SR 51 East of 32nd Street .
14. 32nd Street has recently been repaved. Will this project disturb that new pavement?
 - a. There are different levels of pavement restoration ranging from surface treatment (applying a thin layer of sealant to lengthen the life of the asphalt) to digging up and completely replacing asphalt. Most of the areas we are disturbing may have undergone surface treatment, and we have coordinated with Streets to minimize disturbance to new pavement. We will restore asphalt when the pipeline installation is complete.

15. When will construction impact the Great Hearts Academy?
 - a. Approximately summer 2022. We are working closely with Great Hearts and all nearby schools.
16. When will the construction be near Cholla? (Or any specific area—we have had questions from many people wanting to know when it will be in *their* area)
 - a. See Question 2.
17. When will construction begin?
 - a. Construction of the pipeline is anticipated to begin in the Spring of 2021 starting at the 32nd Street and Bell Road area and heading south. Additionally, utility relocations throughout the area are anticipated to begin in early 2021. Please sign up for email updates so you can stay informed on a weekly basis of the construction activities and schedules. Construction schedules are subject to change.
18. Will there be loud blasting?
 - a. Loud blasting is not anticipated on this project.
19. How are you coordinating with other planned Street Improvements?
 - a. Shea and Cholla—landscape median improvements; get info from Streets <https://www.phoenix.gov/streets>, but we are coordinating closely so they can start their work after pipeline is installed.
20. Will there be restrictions on the pedestrian bridge over SR 51?
 - a. There may be some restrictions.
21. How do you control dust?
 - a. We use water trucks and street sweepers to control dust.
22. When utilities are relocated, will there be disruptions to service?
 - a. Disruptions are not anticipated. Unplanned disruptions are communicated by each utility.
23. Will my water have to be shut off?
 - a. We do not anticipate water service disruption, however, if that need arises, we will notify affected customers in advance.

24. Will you attempt to mitigate traffic redirection through neighborhoods?

- a. Yes, when we plan traffic control in advance, we consider impacts on surrounding areas.
