

Phoenix Offers \$3,000 incentive to 2023 Certified Aquatics Staff



The Phoenix Parks and Recreation Department is offering \$3,000 in incentive pay for certified lifeguards. There is a need to hire pool managers, assistant managers and hundreds of lifeguards ahead of the 2023 pool season to safely open as many of the city's 29 public pools as possible.

Eligible certified managers, assistant managers, and lifeguards will receive \$500 on the first paycheck, and the remaining \$2,500 as a one-time payment at the end of the 2023 pool season.

To receive the pay, a person must become certified as a lifeguard, work the entire summer through Labor Day weekend and finish in good standing.

As Councilwoman and Chair of the Community and Cultural Investment Subcommittee, I am ensuring we deliver the best service to our residents. We must continue to raise wages and benefits for our essential city employees. Our committee will continue to support the important efforts by our Parks and Recreation Department to address the shortages in our lifeguard and pool staffing levels. Volunteers Needed for Tax Season 2023



The City of Phoenix needs your help to save taxpayers hundreds of dollars on filing their taxes. Don't worry, you don't need to be an accountant or a math whiz to give back to your community. The City's Volunteer Income Tax Assistance (VITA) program will provide all the training you need to help low-to-limited-income individuals and families file their returns for free.

VITA volunteers are certified by the IRS to prepare basic tax returns or help taxpayers complete their own taxes using free do-it-yourself VITA tax software. But we need more than just tax preparers to volunteer. Greeters are the friendly faces who welcome residents to their appointment.

Volunteering for VITA doesn't require a huge time commitment and comes with a flexible schedule. We ask that you volunteer for a minimum of four hours per week during tax season from mid-January through mid-April. The training is free and available online to complete at your own pace.

Tree Planting in Parks Report for 2022



We supported a recent tree planting with Alhambra School District and the West Plaza Neighborhood Association at La Pradera Park (39th Ave. and Glendale Ave.). We're grateful for 50 trees that were donated by the ASU Knowledge Exchange for Resilience.

The City of Phoenix plants about 1,500 trees every year. Trees benefit the community by providing a cooling effect that saves lives and reduces energy costs; improving air quality; strengthening quality of place and the local economy; reducing storm water runoff; improving social connections; promoting smart growth and compact development; and creating walkable communities.

The Parks & Recreation Department will plant a total of 592 trees in District 5 by the end of 2022. To support this effort, our office allocated \$30,000 from our council budget from Fiscal Year 21-22. Special thanks for all their hard work of planting hundreds of new trees in our district and all over the City of Phoenix.
