

SBE Certification

Are you a small business owner?

If so, you may qualify to participate in the city's SBE Certification Program. The Equal Opportunity Department certifies small businesses interested in participating in the city's SBE Program. The basic criteria for certification are as follows:

- Primary business located in Maricopa County
- Owner(s) has a personal net worth of less than \$1.32 million (excluding primary residence and interest in the business)
- Owner(s) has the experience and expertise to control the day-to-day critical operations of the firm
- Firm has been operational six months or has completed four contracts/job orders
- Owner(s) is a citizen or permanent legal resident of the United States
- Business qualifies as a small business under U.S. Small Business Administration guidelines and limitations defined in 49 CFR (Code of Federal Regulations) Parts 23 and 26

Small Business Management Technical Assistance

Do you need advice and professional assistance to assist you in taking your business to the next level?

The Community and Economic Development Department Small Business Division provides an array of services to Phoenix-based small- to mid-sized businesses. The overarching focus is the comprehensive Business Retention and Expansion Program aimed at assisting businesses to stay, grow and thrive in Phoenix.

Services include:

- Business technical assistance - general business planning, marketing, accounting, etc.
- Access to capital
- Workforce assistance - customized job recruitment and training
- State and federally funded economic development programs
- Ombudsman services and project management - coordination with city departments including Planning and Development, Street Transportation, Water and Public Works

Procurement Opportunities

Does your business provide goods and general services?

The Finance Department coordinates the city's Reserve Contract Program for certified Small Business Enterprises (SBE).

Reserve Contract Program

The SBE Reserve Contract Program includes opportunities for goods and general services providers to participate in city procurement opportunities. Selected contracts are reserved by the Finance Department for competition only among certified SBE firms.

Construction Subcontracting Goals Program

Do you own a construction-related business?

The Street Transportation Department coordinates the SBE Construction Subcontracting Goals Program aimed at increasing the use of certified SBE firms on city-funded projects. Features of the program include:

- SBE subcontracting goals are established, where appropriate, on city-funded construction contracts of more than \$50,000.
- Prime contractors are required to meet, or make good faith efforts to meet, SBE goals when bidding on city projects.
- The city monitors compliance with SBE bid commitments and resolves program-related disputes between subcontractors and prime contractors.
