#### I. Call to Order and Announcements:

The meeting was called to order with a roll call at 3:13 p.m. There were 5 members present at roll call. At 3:20 p.m. other members joined via phone making a quorum. Call-in phone number confusion delayed a quorum.

### III. Review and approval of April 11, 2019 Minutes:

#### **ACTION:**

Commissioner Elyse Guidas made a motion to approve the April 11, 2019 minutes. Commissioner Ginger Torres seconded the motion and it carried 8:0.

# IV. Presentation: American Forest Urban Forestry

Jad Daley of American Forests presented information about the non-profit organization he represents and how American Forests can partner with the city of Phoenix to improve the urban forest here. American Forests was founded in 1875 and is the oldest national conservation organization in the United States. The organization helps cities through its Releaf Change Model of advocacy and tree planting projects. The model includes building diverse partnerships, developing localized plans based on tree science and using various financing tools and carbon credits where appropriate. Mr. Daley also presented how trees and tree planting can help with Urban Heat island consequences. In a Dallas study, tree planting in the hottest areas with high density residential was found to reduce deaths by 22 percent through merely dropping temperature alone. American Forest has planted over 60 million trees in all 50 states and 45 countries since 1990 through the help of corporate sponsors, that include Eddie Bauer, Coca-Cola, and Bank of America.

Mr. Daley also informed the Commission of how American Forests considers the use of removed trees and works with artisans and furniture makers to innovate methods and market the wood from such trees. American Forests also has a human development mission in building community partnerships, career paths and involving community members in developing arboriculture skills.

In answering a question on the issue of weighing community needs of trees and shade with private property rights, Mr. Daley indicated that American Forests is currently developing a paper on that issue. Attendee Richard Adkins asked how Phoenix could receive assistance from American Forests. Generally, American Forests is best positioned when a community has a specific tree planting or tree promotion project ready to implement. Funding is available; for example, the state of Rhode Island received a two-year grant of \$720,000 to fund a position and resources to develop a state tree planting program that would become self-sustaining.
