# Consideration of Renaming Robert E. Lee Street (Ordinance S-46949)

Request to formally consider renaming Robert E. Lee Street in accordance with the city's Street Naming Policy that allows City Council members to request a change to a recorded street name when it is considered derogatory or offensive based on City Code Section 18-1. Staff requests approval to change the name of Robert E. Lee Street, as well as approval of the proposed new street name selection process outlined in this report, and of the proposed cost reimbursement policy for impacted residents, businesses and property owners outlined in this report. Further request authorization for the City Controller to disburse all funds related to this item.

# **Summary**

In accordance with the City of Phoenix Street Naming Process approved by the City Council on June 27, 2017 (Attachment A), the City Council on July 1, 2020 voted to direct staff to begin the process to consider renaming of Robert E. Lee Street. The Street Naming Process requires conducting two community meetings, which the July 1, 2020 action authorized to be done virtually due to the pandemic. The process also requires a technical review process of proposed new names to ensure conformity to adopted street naming criteria. The Council approved process requires that within 90 days of the request an item be placed on a Council agenda to decide on the proposed street renaming. This report contains detailed information on public input, the technical review of proposed alternate names, a proposed process for additional involvement by Robert E. Lee Street property owners in the selection of a new street name, and a detailed plan to assist residents to update their addresses, including an outline of the cost reimbursement process, should the Council approve renaming of the street.

# **Public Input**

On July 1, 2020, the Council approved the initiation of the process for consideration of renaming of Robert E. Lee Street. That Council action included a temporary process revision to allow the two required community meetings to be conducted virtually due to the COVID-19 pandemic. As stated in the July 1, 2020 Council-approved action: "The current process as approved by Council requires two public meetings to be conducted in the vicinity of each of the streets proposed for renaming. However, because of the COVID-19 pandemic, staff requests as part of this action Council approval to revise the process to allow virtual public meetings to obtain public input from the affected

neighbors and community." Staff conducted two web forums to discuss the proposed renaming of Robert E. Lee Street and obtain community input. Residents were able to participate online or use their phones, including traditional landline telephones, which is similar to public participation at Council meetings during the pandemic. Residents and property owners of Robert E. Lee Street were notified of the opportunity to participate in the meetings through certified mailings, as well as multiple signs placed at various locations along the street. The live community web forums were held on July 28 and Aug. 3, 2020.

The community was also notified of the opportunity to provide input in other ways the City made available. These included:

- Telephone to directly speak with staff
- Comment form on dedicated street renaming webpage: www.phoenix.gov/street-renaming <a href="http://www.phoenix.gov/street-renaming">http://www.phoenix.gov/street-renaming</a>
- Postal mail

In all, 121 people participated in the community forums. In addition to the spoken comments, there were 45 submitted written comments related to the proposed Robert E. Lee Street renaming. Also, to accommodate a request by residents who stated they were not comfortable meeting on the web forums, staff held a socially distanced, mask -required, in-person meeting with a group of 10 Robert E. Lee Street residents in the Paradise Valley Community Center Multipurpose Room on Aug. 10.

For all comments submitted, either in writing or through a forum, slightly more people favored renaming the street. For comments from people that indicated they lived on or immediately adjacent to Robert E. Lee Street, slightly more indicated they opposed renaming than supported it.

**Attachment B** includes all the public input gathered at the web forums, including the attendees' positions on renaming, and a compilation of all comments submitted via email, web comment form, telephone and in writing. Comments from people who indicated they lived on or immediately adjacent (within one block) to the street are listed first and highlighted in yellow on all the meeting and comment spreadsheets.

# Proposed Names

During the public comment process participants proposed more than 80 alternative names for Robert E. Lee Street. City staff performed a technical review of all the proposed names to determine which ones met the criteria outlined in the Maricopa Association of Governments Address and Street Assignment Policy Manual. The proposed names that met the established criteria are listed in **Attachment C**.

The criteria used to assess alternate name proposals first examines availability. If the proposed name is already in use on a street elsewhere in the greater Phoenix area, then it is determined to be not eligible; 41 proposed street names were excluded because of non-availability. This standard excludes those names to avoid adding to the list of duplicate street names and increasing the potential for confusion in emergency calls for Fire or Police services. Staff must also examine street names that may be overly difficult to pronounce or spell; no proposed street names for Robert E. Lee Street were excluded due to this standard. This standard is also related to avoiding confusion for emergency dispatchers and first responders in critical life-safety situations. Lastly, if a name was submitted that was considered obscene or referred to illegal/controlled substances, it was excluded; five submitted names were excluded for this reason.

# Proposed Process for Selection of New Street Name

The proposed new street names listed in **Attachment C** were proposed both by residents living on and adjacent to Robert E. Lee St. and by members of the broader community. Several of the Robert E. Lee St. residents/owners indicated a desire to make the decision or at least have a larger say in the selection of the new street name by being allowed to vote on the new name. Because by ordinance the City Council must take action to vote on the new name, any vote by property owners would be an advisory recommendation to the City Council who would then make the final decision.

In responding to the request from residents, staff proposes the following process for selection of the new street name, if the City Council approves renaming the street:

- The City would conduct a process to allow property owners along Robert E. Lee
  Street to provide an advisory vote to the City Council for the new name of the street.
  The City Council would still be required to take the final action on an ordinance to
  change the name of the street.
- Certified letters would be mailed to property owners of Robert E. Lee Street with a survey containing the list of eligible proposed names that met the City criteria. Each letter would include a unique code that would allow the survey to be returned by mail or be submitted online.
- The survey would use a weighted ranking form of tabulation that would require residents to rank their top five name choices in their order of preference.
- A top-ranked choice would earn the highest numerical value with second, third and later ranked choices yielding correspondingly lower values.
- These ranking values would be totaled at the end of the vote to show the aggregate preference among property owners along Robert E. Lee Street.
- To ensure adequate time is provided, staff estimates this process may take

approximately six weeks before returning to the Council for final action on the new street name.

- The results of the vote would be provided to the City Council at a future meeting along with a request to approve a new street name, along with an effective date.
- Staff will recommend that the effective date of the new name not occur before Jan.
   11, 2021 to ensure sufficient time for residents, property owners and the City to make necessary changes.

# Street Background

Robert E. Lee Street has 131 individual parcels that consists of 88 single-family residential, 29 town homes, two four-unit apartment buildings (eight total units), one charter school (on a residentially zoned parcel) and 11 HOA-owned common-area tracts. The street runs east to west from 52nd Street to State Route 51 with Union Hills Drive the major cross street to the north and Grovers Avenue the major cross street to the south. There is a small non-contiguous section of the street just east of Cave Creek Road (**Attachment D**).

The parcels that make up the current-day street were developed in stages over a 38-year period from 1954 until 1992 (**Attachment E**). The street was unincorporated Maricopa County land until 1988, when it was annexed into the City of Phoenix, as the annotations in **Attachment E** show. Three stretches of the road were dedicated as Lee Street in 1954, 1958 and 1960. Sometime between 1960 and 1961, Maricopa County changed the name to Robert E. Lee Street, which appeared for the first time as a recorded street name in 1961 (**Attachment E**, **page 4**). All street dedications made after that date were as Robert E. Lee Street.

# **Costs**

The Street Transportation Department (Streets) estimates it will cost the City approximately \$3,200 to fabricate and install new signs on Robert E. Lee Street, which will come from funds available in Streets' current fiscal year budget.

The Street Renaming Policy also stipulates that the City cover residents documented direct costs to update their address on personal documents and records, which staff estimates could be approximately \$150 per address. Households are likely to have multiple residents that are impacted, which the estimate intends to account for. Homes that use their address for a registered business also may experience additional costs that exceed a typical residence.

An accurate estimate of resident/owner costs is difficult because in some instances residents have discretion on which documents to replace. For example, banks

contacted by the City have explained that checks with the prior address can still be used as long as the account and routing numbers are the same. Residents can continue to use those checks as is, or simply handwrite in a corrected street name until they exhaust their existing supply. Also, the state Motor Vehicle Services Department (MVD) does not require driver's licenses to be replaced for an address change; the address only needs to be updated in the agency's system within ten days at no cost. However, many people use their driver's license as a form of identification that shows their current address. If a resident chooses to replace their driver's license, per the process outlined below, the City will reimburse the cost to replace it, which is currently \$12.

In some cases, both a property owner who leases their property and tenants will be impacted. Based on the most recent Maricopa County property records available, 27 properties are owned by people with different mailing addresses, which likely indicates properties that are occupied by renters. Should all properties and tenants incur costs at the high end of the estimate, combined costs would be approximately \$24,000. Based on Council approval, the funding will be allocated to the Planning and Development Department budget to cover the reimbursement cost.

# Proposed Cost Reimbursement Policy

Staff proposes the following policy to reimburse expenses for impacted Robert E. Lee Street residents and property owners:

- Property or business owners located on, or any individuals who live on, Robert E.
  Lee Street as of the effective date of the change are eligible to be reimbursed by
  the City for any costs directly associated with address changes related to renaming
  Robert E. Lee Street. The reimbursement will not include any cost for time spent
  making changes.
- City staff will be available to assist residents with any changes, as needed.
- As outlined later in this report, there are also several changes and notifications which the City is making on behalf of residents to reduce the time spent by impacted individuals.
- For reimbursement, affected individuals will need to complete a simple City request form along with receipts or other documentation to the City.
- The forms will be available in paper form for those who prefer to mail hard copies, as well as web forms, through which they can attach scanned receipts and submit reimbursement requests electronically.
- The City standard will be for residents to be reimbursed for eligible costs within three weeks of the City receiving the request.
- There is no time limit for impacted residents to submit for or receive reimbursement of eligible costs.

 There is also no limit to the number of times an impacted resident can submit for and receive reimbursement if all reimbursements are for different eligible costs.

The Planning and Development Department (PDD) will work with the Finance Department to process reimbursements. If for any reason a resident or property owner is denied reimbursement, the decision may be appealed to the City Manager representative within the Planning and Development Department. Staff has created a working draft of a form that residents would use to request reimbursement (

Attachment F). When finalized, this will be adapted as an online form for those residents that wish to submit request forms and receipts electronically.

# City Staff Updating Responsibilities

Should the Council approve a new street name, city staff will send official notification of the name change to an extensive list of agencies so they can update customer addresses in their respective systems. City staff is currently in communication with the Maricopa County Recorder's Office, which will work with the City to record a street name change notification for purposes of deed, deed of trust and voter registration records for impacted residents and property owners. PDD staff will formally notify these City departments: Police, Fire, City Clerk, Finance, Law, Neighborhood Services, Street Transportation, and Water Services. PDD staff also will complete an important notification to the United States Postal Service (USPS). At staff request, the USPS will create a "change alias" in their computer system that ties any new street name for each property to the old street name. Thus, any mail addressed using an old street name will automatically be re-routed to the address with the new name. These change aliases do not expire and will ensure mail sent through USPS will be re-routed indefinitely. All property address numbers will remain unchanged.

Planning and Development Department staff will also send official street name change notifications to the Maricopa County Assessor's Office, Arizona Public Service, Salt River Project, Southwest Gas, Cox Communications, CenturyLink, Federal Express, United Parcel Service (UPS), as well as private mapping services including Google, Bing, Yahoo, MapQuest and Wide World of Maps.

If the Council approves renaming Robert E. Lee Street, staff will send via certified mail a third set of documents to residents and property owners that includes a formal letter of approval, a copy of the recorded ordinance, and a completed address change notification. Residents can keep these documents in their records should they need to document or show proof of the street name change for any reason in the future.

# Resident Assistance

Phoenix Public Library staff will continue to be available to directly assist impacted residents. Staff researched address update processes for multiple agencies to assist residential property owners, rental residents and business owners. Library staff created quick reference lists, complete with hyperlinks, on the street renaming webpage for updating addresses with the MVD, the Internal Revenue Service (IRS), Maricopa County Recorder - Voter Registration and Property Deed/Title, the Social Security Administration and Department of Veterans Affairs. The online guide also has suggestions for updating addresses with insurance companies; cell phone providers; employers; banks, credit reporting bureaus and other financial institutions; schools and childcare providers and online shopping sites. The resource guide for business owners includes quick reference address update links for the IRS, Arizona Department of Revenue, Arizona Secretary of State, Arizona Corporation Commission and business credit reporting agencies. It adds suggestions for updating addresses with customers; banks and other financial institutions; and on websites, social media and other online local search tools. Residents that need or prefer live assistance can speak by phone to Library staff during normal library hours.

# **Timing of Change**

If the City Council approves a new name at the Sept. 16 Formal Meeting, staff recommends that the effective date of a new street name be no earlier than Jan. 11, 2021. This will ensure sufficient time to process changes and avoid any address uncertainty during the upcoming election and holidays.

# **Financial Impact**

The Street Transportation Department estimates a total cost of \$3,200 to fabricate and install new signs on Robert E. Lee Street; the department will use existing fiscal year budgeted funds to cover this cost. Staff estimates approximately \$24,000 is needed to cover costs to reimburse residents and property owners for direct expenses incurred related to changing their address. These funds will be allocated to the Planning and Development Department from the General Fund.

Street Naming Process

# **Background**

- 1. Maricopa Association of Governments (MAG) Address and Street Name Assignment Policy states that a "newly developed street will assume the name of the street on which it aligns."
- 2. North/South streets are typically numbered (per the established grid system).
- 3. All numbered streets west of Central Avenue use Avenue, Drive, Lane, Glen and Dale in that order as the specifically numbered street is located further west.
- 4. All numbered streets east of Central Avenue use Street, Place, Way, Terrace and Run in that order as the specifically numbered street is located further east.
- 5. East/West, angled or loop right of way have a name assigned that is in the same alignment or a new street name is identified per the new name assignment policy.
- 6. City of Phoenix has a nationally recognized reputation for ease of navigation due to consistently adhering to the "Grid" system of named and numbered streets
- 7. For New Name Assignments, the name cannot be used anywhere else in the Phoenix metropolitan area. Names should be short, easy to pronounce, easy to spell, be sufficiently distinct from existing street names and be free of offensive or derogatory language (in any language/translation) based on City Code Section 18-1.

# **Types of Activities**

- 1. New plat with right of way dedication(s) or Map of Dedication (MOD)
- 2. Right of way dedicated but not yet named (separate instrument dedication)
- 3. Street name changes to correct an error
- 4. Requests by property owners to change a recorded street name
- 5. Requests by the mayor or three city council members to change a recorded street name when it is deemed offensive or derogatory based on City Code Section 18-1.

# **Naming Process**

# **Street Name Review for Subdivision Plats and MODs:**

Developer submits Plat or MOD with suggested street names (collector, local) following assignment criteria. Planning and Development Department (PDD) staff reviews and names unnamed streets or works with developer to revise names when necessary. Street names will be identified on plat, MOD, master plan, and site plan.

# Right of way dedicated but not yet named:

PDD names the street in accordance with assignment criteria and requests City Council approval of the naming ordinance.

# Street name changes to correct an error:

These changes are made according to Ordinance G-4593, approved by City Council in April 2004. This process allows the PDD to administratively correct street name errors on newly recorded subdivision plats or MODs. The following are the processes depending on which party initiates the correction or change.

# A. Certificate of Correction initiated by the Engineer of Record for the subdivision plat

## Process:

The Certificate of Correction or Change shall state the following information:

- i. The corrections and/or changes requested;
- ii. The date that the plat was recorded;
- iii. The recording book and page number of the plat which is to be modified;
- iv. Written consent to the correction or change by the current owners of record of all the properties affected by the correction or change;
- v. Signature line for approval by the PDD Deputy Director; and
- vi. Signature line for a representative of the City Law Department approving the form of the Certificate of Correction.

The developer or his representative shall have the certificate or change recorded with the Maricopa County Recorder. A copy of this document shall be filed with the City Clerk Department and notification of the street name change shall be distributed to all interested parties by PDD.

# B. Certificate of Correction initiated by the City of Phoenix

# Process:

The PDD Deputy Director, or designee, prepares the Certificate of Correction stating the following information:

- i. The corrections requested;
- ii. The date that the plat was recorded;
- iii. The recording book and page number of the plat which is to be modified;
- iv. Written notification by certified mail of the correction to the owner(s) of record of all the properties affected by the correction;
- v. Owner(s) shall have seven days to request a hearing before the City Council if they oppose the correction;
- vi. Signature line for approval by the PDD Deputy Director, or designee;
- vii. Signature line for a representative of the City Law Department approving the form of the Certificate of Correction.

The PDD Deputy Director shall have the Certificate of Correction recorded with the Maricopa County Recorder. A copy of this document shall be filed with the City Clerk Department and notification of the street name change shall be distributed to all interested parties by PDD.

# Requests by property owners to change recorded street name:

These changes are made according to City Council policies on street renaming adopted in June 2006 and revised in January 2012.

## Process:

- i. Applicant meets with PDD to discuss the application and submittal requirements
- ii. Upon submittal, the applicant must pay a \$600 application fee in accordance with the PDD Fee Schedule. Additional fees may be applied if permit records and sign changes are required.
- iii. PDD will provide a list of affected property owners to the applicant and direct them to resources indicating tenants on these properties. The list identifies owners of property addressed off of the street. A petition must be submitted with signatures of 75 percent of the affected property owners in support of the street name change. If the application affects 12 or fewer properties, a petition indicating that 100 percent of the owners are in support of the change is required. A notarized Arizona State "Affidavit of Circulation" will be required to accompany the petition.
- iv. There are additional applicant notification requirements for proposed changes to the names of arterial or collector streets. Applicants must notify by mail all owners, residents and neighborhood associations registered with the City of Phoenix Neighborhood Services Department within ½ mile of the affected street for arterials and within 1/8 mile for collectors. The applicant must also mail a proposal letter requesting HOAs notify their members of the proposed change. Applicants must also post a sign (similar to current zoning modification signage) about the proposed renaming before City Council consideration and at time of mailing. Signs must be posted 45 days before City Council consideration for arterials and 30 days before for collectors.
- v. Notification of the name change must be provided to the City of Phoenix Village Planner to be distributed to Village Planning Committee members and/or provided as an information only presentation to the appropriate Village Planning Committee.
- vi. PDD will review the request. This review includes comments from Fire, Police, Water and Street Transportation departments, the United States Postal Service, and will require compliance with the criteria outlined in the Maricopa Association of Governments "Address and Street Name Assignment Policy."
- vii. If the application is denied, the applicant has the option to file an appeal to the City Manager's Representative in PDD.
- viii. If name change is approved by staff, a Request for Council Action will be submitted for approval at a formal City Council hearing.

Requests by the Mayor or three City Council members to change a recorded street name when it is deemed offensive or derogatory based on City Code Section 18-1 as identified by the City Council:

These changes are made according to the City Council policy approved June 27, 2017.

# Process:

- i. The Mayor or three Council members may request initiation of the process to change a street name along with proposed new street name or name options and basis for the change. The request with proposed new street name(s) should be submitted to the City Manager in writing.
- ii. In accordance with established deadlines, at the next available Formal Council meeting, staff will request City Council action to decide whether to initiate the process to review and later decide whether to change the street name. If approved by the full City Council, the process begins, as outlined below.
- iii. PDD will conduct a review of proposed street name(s). This review includes comments from Fire, Police, Water and Street Transportation Departments, the United States Postal Service, and will require compliance with the criteria outlined in the Maricopa Association of Governments "Address and Street Name Assignment Policy."
- iv. Within 21 days of approval by City Council to start the renaming process, PDD will mail the first notice via Certified Mail to residents, businesses and property owners on the affected streets to inform them of the proposal to change the name of their street. Staff will identify all multi-unit properties, either commercial or residential, and consult USPS databases to locate individual unit mailing addresses to ensure all rental tenants receive notification, in addition to the property owner. The letter will contain a phone number and e-mail address to which residents may submit input on the proposed change.
- v. City staff will schedule two public meetings as additional ways for residents to learn about the process and provide input. The meetings will be held in the vicinity of the street proposed for renaming and meeting details will be included in the first resident mailing noted above.
- vi. All results of the technical review will be included in a report to City Council that also will include a map of impacted streets and abutting properties, a comprehensive summary of resident and business and property owner input on the proposed street name, a detailed estimate of city costs to replace street signs and a potential source of funding to cover those costs. The report will include an estimate of any financial impact to property owners, business owners and residents for required updates to addresses that would result from a street name change. It will also identify potential city funding for Council consideration to cover the costs, with the goal to ensure property owners, business owners and residents would not need to cover any required financial costs. It will list the steps staff will take to assist affected individuals with any additional notifications and processing of address changes, as requested, to reduce inconvenience and time impacts on property owners.

- Staff also will evaluate potential timing issues that may need to be considered and will make a recommendation for an effective date to minimize any negative impacts.
- vii. Within 90 days of the request, an item will be placed on a Council meeting agenda for the City Council to decide on the proposed street name change.
- viii. Fourteen days prior to the meeting at which the City Council will vote on the proposed name change, PDD will mail via Certified Mail the second required notice to all affected property owners to inform them of the date, time and location of the Council meeting.
- ix. If City Council approves the renaming of a city street, PDD will compile and then share with residents a comprehensive resource list that includes hyperlinks and other contact information to minimize the time and inconvenience of updating addresses on personal accounts.
- x. If Council proposes to change the street to an alternate name that had not been reviewed, the alternate name would require additional analysis and up to 60 additional days for technical review.

# After City Council Approval of a Name Change

Any City of Phoenix fees related to changing of a street name under the provision approved June 2017 will be waived for affected property owners and/or residents. The City will notify the USPS, which will update their database to ensure that any mail sent to an address with the previous street name will be delivered to the address under the new street name. PDD also will notify the Police, Fire, City Clerk, Finance, Law, Neighborhood Services, Planning and Development, Street Transportation, and Water Services departments, Maricopa County Recorder, Maricopa County Assessor, Arizona Public Service, Salt River Project, Southwest Gas, Cox Communications, Century Link, Federal Express, United Parcel Service, and private mapping services such as Google, Bing, Yahoo, MapQuest and Wide World of Maps.

PDD also will send to each property owner a notification letter of approval, an Address Change Notification and a copy of the ordinance. These can be presented by the property owner to any private entity that may request official documentation.

Open letter to the people who may attend the limited acccess meeting at the community center at Paradise Valley Park Monday August 10th 2020.

I thank the City Managers office for sending a representitive to hear our concerns. Many of us were denied the right to participate in the "live web-conference" process because of the excluding process of either no computer or limited computer equipment. Some people did not know how to downdoad the city's process in order to "register". I feel this exclusion process was planned and rushed thru.

This limited meeting tonight, and others to come, have at least two pruposes for us. -One- is for each person, allowed to attend, to have the right to speak their mind, ask questions and expect truthful answers.

-Two- is to inform the resident owners of Robert E. Lee St. of their rights.

The City Of Phoenix is not the last word in this matter. There is no time limit on correcting the mistakes of this public limiting process.

Other neighborhoods may soon be faced with this same rush to rename their street or other issues the City hopes to rush thru their agendas. If this practice of using the "live web-conference" is allowed to be used as an acceptable means the City may then assume the practice is, by their definition, the "law of the land". No so!

It is our right and duty to reestablish all citizens rights to due process thru the legal process of meetings and forums where all people can attend together and exchange ideas in the presence of each other.

My many years in Maricopa County and the City of phoenix have shown me other issues of deception by some of the City Council members. Deception and lies surrounded the Sumotomo Plant for instance. Promises not kept of sidewalks, street lights and sewers at low cost, are examples of a few. District 2 is much wiser now.

When annexed in 1988 our water bills trippled, same water, same pipes, same well. Seven years ago our street was torn up for new water lines. The street was only patched and the cross street cuts are still a problem to traffic and crumbling. "Whats the hurry"? Our street light at 40th St and Robert E.Lee has been out since Sept 2019, after many calls. "whats the hurry"? We were promised sidewalks as part of annexation 32 years ago. "whats the hurry"? Kids walk to school in the street, people with pets walk in the street, mothers with strollers walk in the street, joggers run in the street. "whats the hurry"? Out fire hydrant was not turned on for six years after installation. "whats the hurry"? Now this name change process is to an emergency?

Why is there a rush using an unconstitutional process to limit access to the few? "whats the hurry"?

ADA installed concrete corners with no sidewalks added on our street? "whats the hurry"?

The city sent me a list of people to contact due to the name change. No promises to pay and a total disclamer at the end. It was never planned by the city to pay our expenses. Expenses for this name change will go on for many years. What does the city plan for our future expenses? We have been left to do the necessary changes ourselves and our time is not reembursable. To keep every receipt and send it in is also a cost. Since the City has sole authority to judge these receipts, what is the guarantee of any timely payment? How soon will the city decide to cut us off? I suggest 20years of no hassle reembursement and a process of accountability with the city. The city has a long history with District 2 of forgeting their promises.

We did not create this situation and should not be denied our right to just compensation. Our loss of personal time will be felt for many years.

The city has voted themselves the right to claim our votes in the renaming process thru Council action over the past few years. This never passed the smell test. As citizens of Robert E. Lee St. we saw this coming but never saw the process of taking away our voice also thru the use of the rushed "live web-conference" process.

Also what about all mail and package deliveries after the name change? We deserve fair treatment with mail and package delivery uninterupted for the next 20 years.

The cutizens have the right to challenge the city, on many fronts, as we have in the past.

Many of my neighbors understand we are not opposed to a name change but to the process used by the city to limit the citizens input and the unnecessary rush job after all these years. Hold this renaming process until due process can include all citizens as required by the State Constitution and the City Charter. "what is the hurry"?

Who are the people who advancesd this "live web-conference"? What is their future agenda for other communities as well? If this process is not stopped the Council may assume it is a form of law and will feel empowered to use it again and again to get their way.

I for one do not accept this type or deceit and it will long be remembered. Remember a previous Council member who lied to us in District 2.
