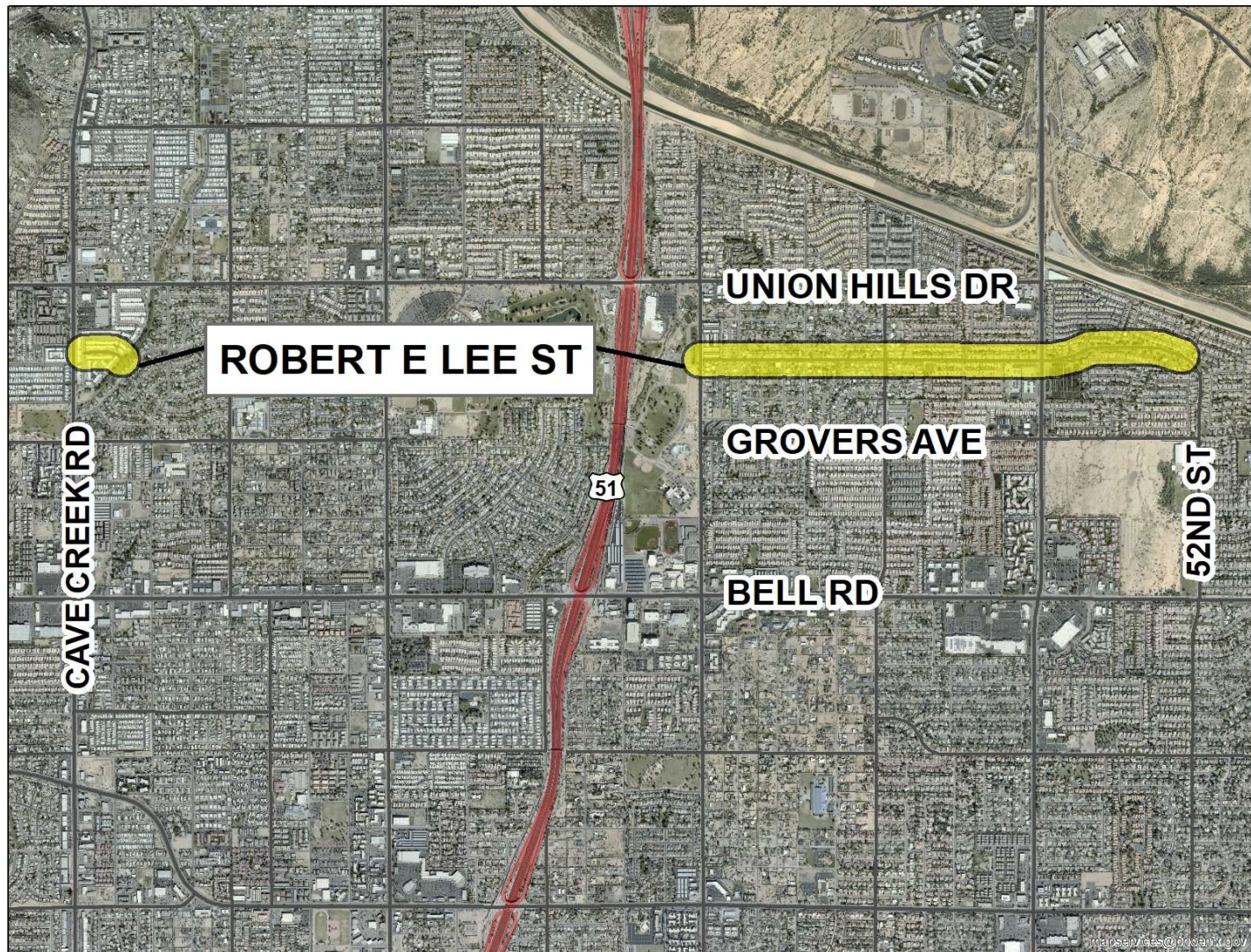


Proposed New Street Names

 - **Justice Street**
- **Community may Propose Additional Names to Consider**
- **City Council Decides New Street Name along with decision to rename**

Technical Report

- **Compile report with the following:**
 - **Maps of impacted streets/properties**
 - **Summary of public feedback**
 - **Research proposed street names**
 - **Cost estimate to replace signs**
 - **Source of funding to replace signs**



Technical Report

- **Compile report with the following:**
 - **Estimate of financial impact to property owners, business owners and residents**
 - **List steps staff will take to assist affected individuals**
 - **Evaluate implementation timing issues**
 - **Recommendation of effective date of new name**
