Improvement Project

The contractor will begin installation of electrical and landscape underground conduit in 5th Avenue on **June 3, 2020** for approximately 4 to 6 weeks. Construction of the pedestrian and bicycle improvements will follow.

Boring and trenching operations will occur intermittently in the intersections of McDowell Road, Lynwood Street, Willetta Street, and Culver Street.

What to Expect

- Contractor's work hours are generally between 6:00 am and 4:00 pm Monday thru Friday.
- Underground boring operations will be utilized wherever possible, however open trench operations will be required at some intersections.
- Intermittent sidewalk closures may occur.
 Pedestrians will be detoured around construction sites.
- On-street parking restrictions will occur Monday thru Friday from 6:00 am to 3:00 pm.
- Traffic will be restricted adjacent to the contractor's work areas with one lane of traffic maintained on alternating east and west sides of the road.
- Traffic detours will be required at some locations. All vehicles and bicycles will need to follow the posted detour routes.
